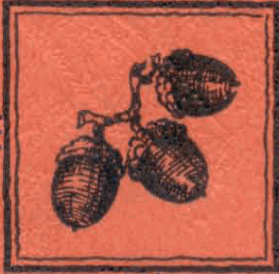

EARLY HISTORY OF OAKLAND COUNTY

The first official act relating to the county of Oakland of which any record can be found is an executive proclamation issued by Governor Cass which bears the date 12th day of January, 1819.

PROCLAMATION

Whereas, "in brief"—A petition has been presented to me by citizens of said territory requesting boundaries of a new county and seat of justice. I hereby appoint John L. Seil, Charles Larned, Philip LaCuyer, John Whipple and Thomas Rowland commissioners for the purpose of examining the said county, and reporting the most eligible site for seat of justice.

On the 28th of June 1820 the governor divided the county into two towns, Oakland and Bloomfield.

On July 17, 1820 a county court assembled at Pontiac. William Thompson had been appointed chief justice, Daniel Bronson and Amason Bagley, Esqs. associate justices. William Morris had been appointed sheriff and Sidney Dole county clerk.

"The first public buildings in Oakland County were erected in 1823-24 or at least their erection was begun at that time. They were a court house and jail combined in one building, which was built of squared logs and frame-work, the lower portion being used for jail purposes and the upper, or second story, the frame portion, being used for a court room. Major Oliver Williams of Waterford, had the contract for getting out the timber, and the plank of which the cells were made, which was six inches thick, was sawed at Mack's Mill, Colonel Almon Mack acting as sawyer. The jailer's residence was in the upper story of the building also. The proprietors of the Village Plat of Pontiac made large concessions in aid of the erection of this building, subscribing heavily thereto. It stood very near the location of the present court house."

OAKLAND COUNTY COMMISSIONERS

Under the Territory law three commissioners were appointed by the governor to transact the necessary county business, which law continued in force until 1825, when the office became elective and continued until April 12, 1827 when an act was approved formally abolishing this board of commissioners.

THE FIRST COMMISSIONERS APPOINTED to this office in 1820 were Ziba Swan, Enoch Hotchkiss and Johnathan Perrin.

THE FIRST COMMISSIONERS ELECTED to this office in 1825 were Steven Reeves, William Burbank and Arthur Power.

BOARD OF COUNTY COMMISSIONER formally abolished, April 12th, 1827.

BOARD OF SUPERVISORS

On March 30, 1827, an act of the legislative council of the Territory was approved, providing for the election in each township of a supervisor and other township officers. On the same day another act of council was approved providing for the meeting of the supervisors of the several townships at the county seat annually to perform the duties theretofore imposed on the county commissioners.

On April 12, 1827 an act dividing the county into townships was approved; County being divided into five townships, Oakland, Troy, Bloomfield, Farmington and Pontiac.

"This act appears to have been adopted prior to this date as on March 30 of the same year an act was approved providing for the election of townships' supervisors and other township offices."

BOARD OF SUPERVISORS

Reference: VOL. 1 of BOARD OF

First session July 1827.

At a meeting of the Board of Supervisors for Oakland County held at the court house in said County on the third Monday and Tuesday in July in the year of our Lord one thousand eight hundred and twenty-seven.

PRESENT

Roger Sprague, Jacob N. Voorheis, Steven V. R. Trowbridge, Lemuel Castle and Amos Mead Esqs. Supervisors.

First official act after current bills had been taken care of, was (in brief): Resolved that a reward of five dollars be allowed to any white person or persons who shall kill or destroy any wolf or wolves, panther or panthers, and 2½ dollars be allowed for the destruction of each whelp of any wolf. The first person to receive a reward under this new resolution was Enos Parker who was paid \$5.00 for the killing of a wolf, certified by Laban Jenek, Justice of the Peace. Dated Bloomfield, June 30, 1827. In January session 1828, Nathan Power was the second person to receive \$5.00 for the killing of a wolf by hired man (William Tibbets) in Farmington township.

In 1840 the population was 23,646 or a trifle over eleven percent of the entire population of the State. The early population was drawn mainly from the State of New York. Wayne County population only outnumbered it by less than 1000.

The county has over 400 lakes covering an area of fully 20,000 sq. acres. Cass Lake is the largest, covering 2000 to 2500 sq. acres. Orchard Lake covers some 1400 acres.

The Oak was particularly abundant, and the openings in the oak forest, so beautiful a product of nature, were highly prized by the pioneers. The valuable tracts of this hardy wood and the beauty of the oak-rimmed lakes is perpetuated in the name of the county.

ORDER OF BUSINESS

- 1st. Reading of Minutes
- 2nd. Special Order of Business
- 3rd. Report of Standing Committees
- 4th. Report of Special Committees
- 5th. Resolutions and Communications
- 6th. Unfinished Business

Rule I. The Chairman shall take the chair at the time the Board stands adjourned, and the Board shall be called to order and the Roll of members called.

Rule II. Upon the appearance of a quorum the Journal of the preceding day shall be read by the Clerk, and any mistake therein shall be corrected by the Board.

Rule III. The Board shall appoint a Chairman pro tempore, who shall perform the duties of the chair in the absence of the Chairman.

Rule IV. The Chairman shall preserve order, and shall decide questions of order, subject to an appeal to the Board.

Rule V. Every member, when he speaks, shall address the Chair standing in his place. No member shall speak more than twice in any one debate on the same day without leave of the Board.

Rule VI. When two or more members rise at once the Chairman shall name the member who is first to speak.

Rule VII. No motion shall be debated until the same is seconded; and it shall be reduced in writing if desired by the Chairman or any member, delivered at the desk and read by the Chairman or Clerk, before the same shall be debated, but it may be withdrawn any time before decision or amendment.

Rule VIII. When a question is under debate, no motions shall be received but to adjourn, for the previous question, to lay on the table, to postpone indefinitely, to postpone to a certain day, or to amend; which several motions shall have precedence in the order in which they stand arranged.

Rule IX. A motion to adjourn shall always be in order. That and the motion to lay on the table shall be decided without debate.

Rule X. The previous question shall be in the form "Shall the main question be now put?" It shall only be admitted when demanded by a majority of the members present, and its effect shall be to put an end to all debate and bring the Board to vote upon pending amendments and then upon the main question.

Rule XI. When a member shall be called to order, he shall sit down immediately, until the Chairman shall have determined whether he is in order or not; and any questions of order shall be decided by the Chairman, subject to an appeal.

Rule XII. A motion to convene as a committee of the whole shall be in order when there is no privileged motion before the house, and when carried by a majority of the members voting the house shall convene, but any action taken in committee-of-the-whole must be confirmed in the regular session of the Board.

Rule XIII. No member shall absent himself from the Board without leave first being obtained and no member shall draw compensation unless he shall have answered roll call at least once each day or has himself recorded present during said session.

Rule XIV. Ayes and Nays shall be ordered when demanded by any member of the Board provided said member shall demand same before the vote is ordered.

Rule XV. Each member shall be required to vote on every question unless excused by the Chairman.

Rule XVI. When a question has been once put and decided by ayes and nays, it shall be in order for any member (voting in the majority) to move a reconsideration thereof. On all other questions any member may move a reconsideration. But no motion for a reconsideration shall be in order unless made on the same day, or succeeding day, on which the vote was taken, nor shall any question be considered more than once without unanimous consent.

Rule XVII. After the ayes and nays are called upon any question, and after the question is stated from the Chair, and the Clerk directed to call the roll, no member shall be entitled to speak on the question.

Rule XVIII. Select committees to whom reference shall be made shall in all cases report a state of facts, and their opinion thereon, to the Board.

Rule XIX. When the Board adjourns the members shall keep their seats until the Chairman announces adjournment.

Rule XX. Section 1. The following standing committees shall be appointed by the Chairman during the first session of the Board and shall be composed as follows:

Section 2. The Board of Supervisors may by resolution create Special Committees with a definite assignment and when so created such committees shall hold over until their assigned project is completed unless sooner discharged by a majority vote of the Board of Supervisors but the Chairman shall have the same power of appointment of such special Committees as he has in the case of standing committees.

Section 3. The Chairman of the Board shall be empowered to fill all vacancies on Committees caused by resignation or otherwise.

Rule XXI. Section 1. All requests, communications, petitions or questions brought before the Board by any County Officer or County Board, or any other party or organization, shall be submitted in a written or printed form, and unless otherwise ordered by the Board, referred by the Chairman to the proper Committee for consideration.

Section 2. All requests, communications, petitions or questions brought to the attention of the Clerk and/or the Chairman of the Board, when the same is not in session, may be referred by the Chairman, without convening the Board, to the appropriate standing committee, and in the event no appropriate standing committee exists, then to the Miscellaneous Committee.

Section 3. It shall be the duty of such committees to prepare the necessary facts and details concerning the matters so referred, including the opinion of the Civil Counsel as to the legal principles involved therein, notify the Chairman when such information is ready and make a written report to the Board when the same convenes, with or without recommendations.

Rule XXII. No standing rule of the Board shall be rescinded, changed or added to, except by the consent of a majority of the members elect of the Board and with one day's notice of the motion thereof.

Rule XXIII. The rules or parliamentary practice as comprised in "Roberts' Rules" shall govern in all cases in which they are not inconsistent with the standing rules and orders of the Board or the Constitution or the laws of the State of Michigan.

PRIVILEGED QUESTIONS

Rule XXIV. Privileged questions are questions that may be considered when other questions are pending. They are:

- 1st. To adjourn.
- 2nd. To adjourn to a certain time.
- 3rd. The previous question.
- 4th. To lay on the Table.
- 5th. To postpone indefinitely.
- 6th. To postpone to a certain length of time.
- 7th. To commit or to amend.

The first, when made and seconded, is always in order. The first, third and fourth must be decided without debate.

PREVIOUS QUESTIONS

Rule XXV. The previous question, when moved and seconded, is a motion to determine all amendments to the question pending and the pending question itself, without further amendments or debate, or before any other motion is in order, except to adjourn. It shall be stated in the form, "Shall the main question be now put?"

RECONSIDERATIONS

Rule XXVI. A motion for reconsideration may be made by any member of the prevailing side within one day after the question was determined, but if such motion be laid on the table it shall there remain.

MOTIONS

Rule XXVII. When a member desires to make a motion he shall arise and address the Chair, and when recognized by the Chair he has the floor to make his motion, and if the motion is seconded, it shall be stated by the Chair after which it may be debated.
