### **FRONT COVER:**

Visitors to the Oakland County Courthouse will see some very noticeable changes when they pass through the security entrance located at the north end of the courthouse. The lobby has undergone radical changes over the past seven months which will provide courthouse security with additional space to accommodate check point equipment, while also providing the public with easier access to the courthouse.

Two thousand square feet was added to the north lobby at a cost of \$1,662,000. Minoru Yamasaki Associates of Rochester Hills performed the architectural work. John M. Olson Company of St. Clair Shores was the project contractor.

The new lobby, which complements the existing buildings and surrounding campus, is comprised of structural steel frame with architectural precast concrete panels, energy efficient glass, durable terrazzo floor and marble walls. The new structure also comes equipped with a full sprinkler and fire alarm system and computer controlled HVAC for optimum energy efficiency.

The new lobby was opened to the public on March 24, 1996.

## DISCOVER THE OAKLAND COUNTY PARKS

With preservation of open greenspace a top priority, the Oakland County Parks and Recreation Commission strives to enhance quality of life for its 1.5 million annual visitors.

Recreational, leisure and learning experiences are made possible through special events, programs and facilities supported, in part, by a one-quarter mill tax. Since 1966, Oakland County residents have voted to support the parks system at an annual cost of \$12.50 (per \$100,000 home).

More than 5,600 acres of land have been acquired by the Oakland County Parks since 1966, with assistance from state and federal grants.

Ten citizens comprise the policy-setting parks commission. The 11 Oakland County Parks function in an environmentally-sensitive manner to protect the natural world for future generations.

A leader in innovative facilities and programs, the parks offer two wave-action pools with waterslides — one waterpark features a children's water playground and a group raft ride; Michigan's first refrigerated toboggan run - "The Fridge"; a year-round, dome-covered driving range, a nature interpretive center, an outdoor amphitheater and a community mobile, recreation fleet.

A new 3,000-square-foot addition at Glen Oaks Golf Course includes expansion and interior renovation of the existing banquet room, lower level golf cart storage and parking lot expansion. Renovation of the campground at Groveland Oaks County Park will reduce the total number of sites from 600 to 475, easing camping congestion and improving traffic flow. The project includes installation of 157 new modern sites, enlarged group camping, realignment of park roads and expansion of the day use parking lot.

**Addison Oaks:** The 794-acre park offers swimming, fishing, boating, camping, disc golf, cross-country skiing and ice skating. Addison's trail system is used by hikers and mountain bikers. Primitive and modern campsites with water and electricity are available. Four overnight rental cabins feature two bunk beds, electricity, a refrigerator and table with chairs. A conference center hosts business and social gatherings. On West Romeo Road, nine miles north of Rochester. (248) 693-2432.

**Glen Oaks:** The 18-hole, par 70 golf course features a clubhouse with banquet facilities and lounge. Cross-country skiing is a winter option. On Thirteen Mile Road between Middlebelt and Orchard Lake Roads, Farmington Hills. (248) 851-8356.

**Groveland Oaks:** Campers have a choice of 475 campsites plus four overnight rental cabins with swimming, a waterslide, fishing, boating and the largest playscape in the Oakland County Parks system. Off Dixie Highway at Grange Hall Road, Holly. (248) 634-9811.

**Independence Oaks:** Activities at this 1,088-acre park include boating and fishing on 68-acre Crooked Lake plus swimming, hiking, cross-country skiing and other winter sports. The Lewis E. Wint Nature Center offers year-round nature interpretive programs, exhibits and educational outreach programs. The Cohn Amphitheater and Rubach Sensory Herb Garden and paved All Visitor Trail were made possible through the Oakland Parks Foundation. On Sashabaw Road, 2.5 miles north of I-75. Park: (248) 625-0877; Nature Center: (248) 625-6473.



**Lyon Oaks:** This environmentally-sensitive 773-acre park is home to many birds and wildlife. Once developed, Lyon Oaks may be used as an environmental resource and for hiking, cross-country skiing and picnicking. Bordered by Pontiac Trail, Old Plank Road and I-96 in Lyon Township. (248) 858-0906 for information.

**Orion Oaks:** Lake Sixteen can be used for boating or fishing from a handicap-accessible dock off Joslyn Road. Limited hiking and cross-country ski trails are also available on Orion Oaks' scenic 927 acres. Bordered by Clarkston, Joslyn and Baldwin Roads in Orion Township. (248) 858-0906 for information.

**Red Oaks:** The Madison Heights **Waterpark** features a wave-action swimming pool, three-flume waterslide, deck and lawn area for sunbathing, picnic facilities, sun shelter, bath house and concessions. A 9-hole, par 31 **Golf Course** is on John R Road, between 12 and 13 Mile Roads. Across John R is a **Sports Village** with indoor and outdoor driving ranges, mini-car track, batting cages, 36 holes of adventure golf and children's playscape. Waterpark: (248) 585-6990; Golf Course: (248) 541-5030; Sports Village: (248) 548-1857.

**Rose Oaks:** Encompassing 613 acres, the system's 11th park was acquired in 1994. The site features three different ecosystems including 200 acres of wetlands, as well as frontage on two lakes. When developed, the park may be used for hiking, boating, fishing, swimming, picnicking and cross-country skiing. On Fish Lake Road, north of Rose Center Road, Rose Township. (248) 858-0906 for information.

**Springfield Oaks:** The Springfield Oaks complex includes an 18-hole championship **Golf Course** (par 71) and a multi-purpose **Activity Center** for banquets, receptions, shows and 4-H events plus two outdoor arenas. On Andersonville Road in Davisburg. Golf Course: (248) 625-2540; Activity Center: (248) 625-8133.

**Waterford Oaks:** The 154-acre park is home to the commission's administrative offices. Waterford Oaks also offers a **Court Sport Complex** with eight tennis courts, two platform tennis courts, eight sand volleyball courts, shuffleboard, horseshoes courts, picnic shelters and children's play equipment. The park boasts **Michigan's first wave-action pool and double waterslide plus a group water raft ride and children's water playground**. The park is also home to "The Fridge" - **Michigan's first refrigerated toboggan run**. The **Activity Center** is popular for weddings, recreation programs, banquets and parties. Classes, such as dog obedience, golf and aerobics, are also offered. In Waterford on Watkins Lake Road. Activity Center: (248) 858-0913; Waterpark: (248) 858-0918; Court Sport Complex: (248) 858-5433; BMX: (248) 858-0915; Refrigerated Toboggan Run: (248) 975-4440.

**White Lake Oaks:** At this 18-hole, par 70 course, facilities include a clubhouse with a pro shop and restaurant. A private room accommodates up to 250 persons for parties. On South Williams Lake Road off M-59, near Pontiac. (248) 698-2700.

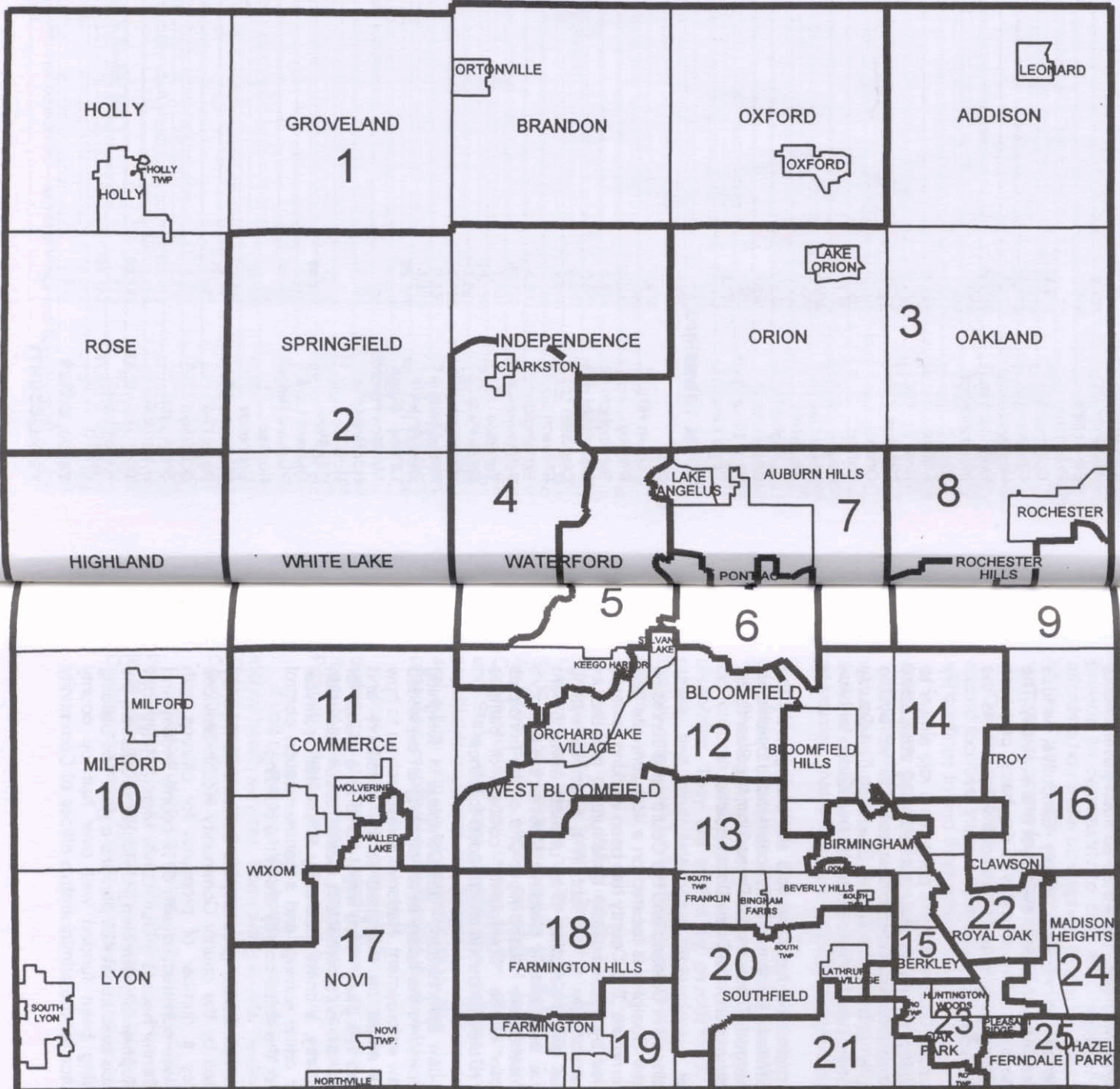

## **OAKLAND COUNTY GOVERNMENT**

In August of 1974, Oakland's citizens voted to create the *first unified form of county government* in the history of Michigan. Less than 60 such governments exist across the nation.

The government is headed by an elected County Executive, whose responsibilities are similar to those of a governor or the mayor of a large city. The County Executive administers the government on a day to day basis, proposes new programs and revamps existing programs. The executive represents the interests of more than one million residents.

Under this structure, the Board of Commissioners performs a role similar to a state legislature or city council. It acts on proposals submitted by the County Executive and makes proposals of its own. Government policy is set by the Board of Commissioners and implemented by the County Executive. The County Executive may veto acts of the Board and the vetoes can be overridden by two-thirds vote of the Board.

The third branch of government, the judiciary, was not changed by the executive form of government. Similarly, the five other offices headed by officials elected countywide remain unchanged. These are the Prosecutor, the Sheriff, the Clerk/Register of Deeds, the Treasurer and the Drain Commissioner.

## **SERVICE CENTER COMPLEX**

Such a center has been developed in Oakland and the Courthouse serves as its focal point. The Service Center Complex is located on a 450-acre site and serves as the hub of county government. The County has been working towards the development of this complex by systematically constructing facilities as needed and funds permit. The complex is laid out in a spacious setting according to a master plan, thus giving direction to an ultimate development which will be functional as well as aesthetically pleasing. Most of the County's departments and institutions presently are housed here. One of the principles designed into the Service Center is the "Community" concept of campus development whereby similar or related functions are grouped together.

At the Service Center is the Law Enforcement - Jail Complex. In designing the Complex, the County has looked to the future in anticipating an expanded role for Sheriff's Department in law enforcement. Nationwide research as to how a jail and its related facilities might be designed to be functional and operationally efficient has resulted in a plan, which might serve as a model for other local agencies who deal in law enforcement. A closed circuit television system for surveillance and security, a crime laboratory to provide technical assistance on a local basis for crime solving, and a communication control center for the law enforcement for the entire county are in the building.

A second Complex on the Service Center grounds, the Oakland Community Mental Health Center, is operated by the county Community Health Services Board. The Center consolidates a number of programs for citizens with developmental disabilities, and was constructed with 60% county money and 40% Federal grant funds. The Center houses a Community Mental Health day program for more than 130 developmentally disabled individuals; in addition, the Counseling and Evaluation Service sees about 425 persons a year. The building is unique in Michigan in having been funded well over half by county government; it also provides space for the administrative offices of Community Mental Health.



The Children's Village also is on the Service Center grounds. It provides shelter, care and treatment services for neglected and delinquent wards of the Court. Situated on fifty acres in the Service Center, it consists of small units which provide an opportunity to deal with individual problems of youth. The Village affords a home-like atmosphere to the troubled children coming to the attention of the Court. It is a model which evokes considerable favorable reaction from visitors and judges from throughout the State and other areas of the country.

Oakland's officials are proud of the County Courthouse Complex and its related facilities. Visitors from other counties, states and nations have found and will continue to find themselves most welcome.

### **OAKLAND COUNTY COMMUNITY MENTAL HEALTH SERVICES**

Some people have serious, persistent psychiatric problems that can interfere with their whole life, especially on the job, in school, or in relationships with family and friends. Others are born with a developmental disability such as mental retardation, that will require special programming and services.

Oakland County's Community Mental Health Services, a part of County government, can help with these problems. There are seven major outpatient "case management" programs funded by Community Mental Health for adults and children with psychiatric and emotional impairments and developmental disabilities. They are staffed by psychiatrists, social workers, psychologists, nurses, and other healthcare professionals. Some programs are staffed by County employees while others are run under contracts with Community Mental Health.

Fees are on a sliding scale, based on the individual's ability to pay, and Community Mental Health services are approved for reimbursement by Medicaid, Medicare and various health insurances. The outpatient programs are part of a \$100 million system directed by the Oakland County Community Mental Health Services Board, whose members are appointed by the County Board of Commissioners, and funding for the program comes primarily from the County and State. The total system also includes 24-hour crisis services, inpatient psychiatric treatment, day programs for adults and children with mental illnesses and adults with developmental disabilities, various specialized residential care programs, respite care for families, and a wide range of specialized services.

Most Community Mental Health programs are open Monday through Friday during day and some evening hours. At night and on weekends and holidays there is a Crisis Service operated by Common Ground and Sinai Hospital in Pontiac; their help is available by phone or on a walk-in basis.

If you or someone you know — an adult or a child — may need professional mental health services, Community Mental Health is ready to help any way it can. These programs are supported by your tax dollars for the benefit of all Oakland County residents.

## OAKLAND COUNTY ROADS

More than half of all highways, roads, and streets in Oakland County are on the county system, which is under the jurisdiction of the Board of Oakland County Road Commissioners.

The Road Commission for Oakland County is now in its 84th year of service to the people of Oakland County.

Totaling over 2,500 miles, this system includes all public roads in townships, and through-streets in most cities and villages. It is the longest county system in Michigan and is second in size only to the state highway system. Its subdivision streets alone (all in townships) make up more than 900 miles.

About two-thirds of the system is paved. More than half is within the county's urban area, where some roads are four and five lanes wide to handle heavy traffic. A single intersection, in Southfield, is the meeting place for 100,000 vehicles daily. More than 1,000 electrical signals and more than 82,400 signs are in use on the county road system.

The road commission does not levy a countywide tax, nor does anyone levy a tax countywide for roads.

The basic source of road commission revenues are the state - collected vehicle fuel and registration taxes, which motorists pay at the pump and to the secretary of state. The state-collected taxes are the only source of substantial funding for county road maintenance, and snow and ice control.

Federal, county, municipal, township, and property-owner contributions are also received, but generally only for specific road projects. Such projects include adding lanes, intersection improvements, paving gravel roads, adding new gravel, resurfacing paved roads, passing lanes, and other safety improvement projects.

In 1992, the Road Commission for Oakland County embarked on a program called FAST-TRAC, which is an ITS (Intelligent Transportation Systems) effort. The road commission has installed electronic traffic signals operated by computers and video vision in the cities of Troy, Auburn Hills, Rochester Hills, Novi, South Lyon, and Walled Lake. FAST-TRAC also incorporates the Siemens Automotive ALI-SCOUT system, which can give verbal and graphic directions to drivers. This system is the first adaptive traffic control system in the United States, and the road commission is the first local unit of government to initiate a program of this scope and magnitude.

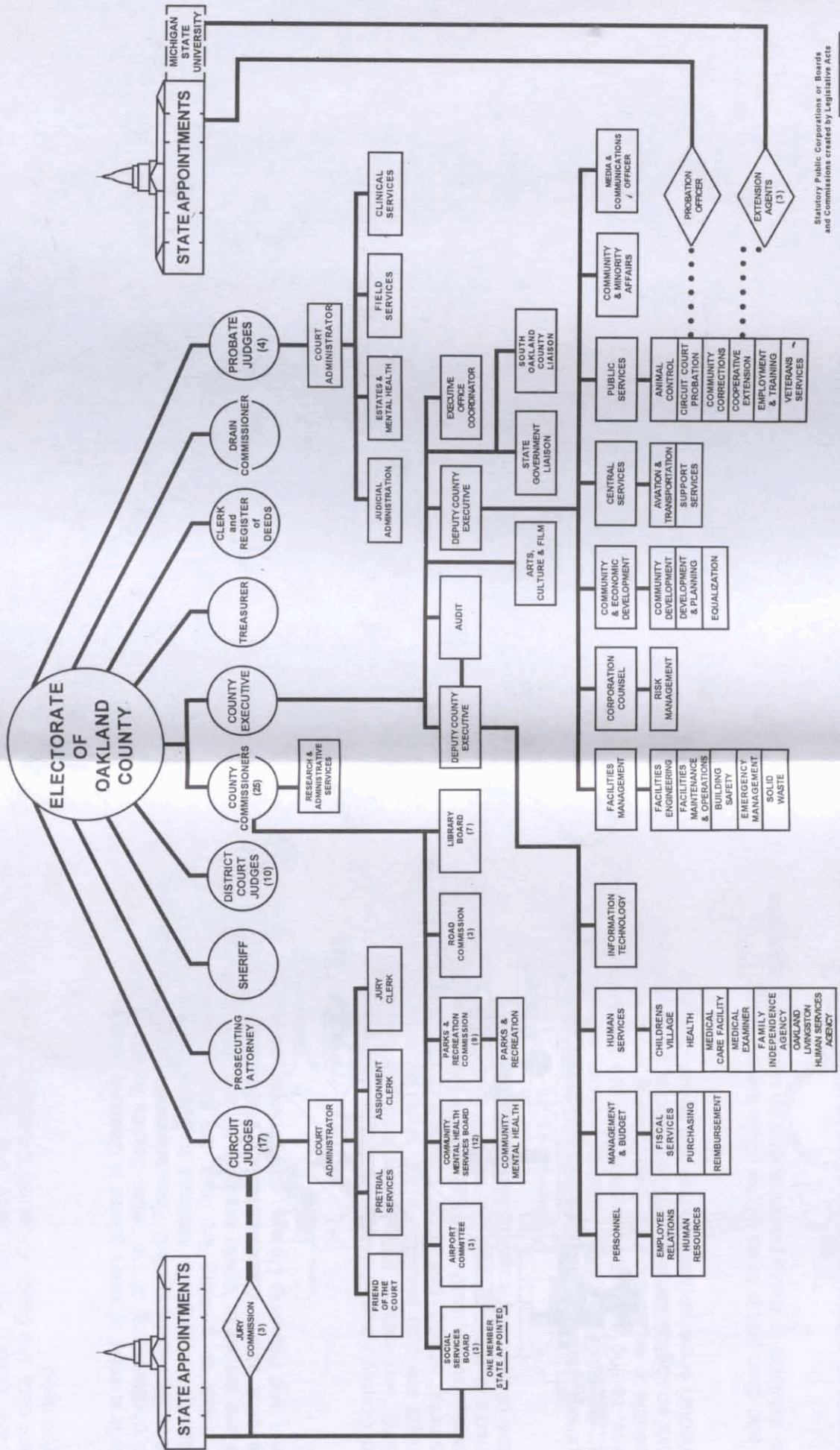
For paving and resurfacing of subdivision streets, property owners can specially assess themselves through a process prescribed by state law. The process begins by contacting the road commission, then petitioning and participating in public hearings.

Members of the three-person Board of County Road Commissioners are appointed for staggered six-year terms by the elected Board of County Commissioners, which also sets their salaries. Salaries are funded by state-collected vehicle fuel and registration tax revenues. The Board of Road Commissioners is separate from county general government — establishing policies as authorized by state statutes for management of the countywide road system, administering its own budget, and hiring its own full-time managing director and staff.

If you are looking for property line maps, aerial photography or development data, the Oakland County Development and Planning Division has what you need.

Property line maps of every parcel in Oakland County are updated each year. Aerial photography of the entire County is also available - our most current edition was taken in 1990. The aerials can be superimposed with the current property line maps or enlarged to a scale where detail as fine as telephone poles or parking lot lines are easily visible. Realtors and developers use aerials to locate available vacant land. If you ever need an aerial view of a street, home, place of business or accident site, the Development and Planning Division can provide you with a custom aerial enlargement.

Oakland County Street-Index maps are printed in four quadrants (NE, NW, SE, SW), and include local information and places to see. Special "theme" maps are also available which show such topics as zip codes, school districts, voting precincts, population densities, planned road improvements, sewers, land use, and natural resources, as well as lands already zoned industrial, commercial, office or multi-family but vacant. These are just a few of the many maps available.

Development data and statistics are also available in a complete and user-friendly format. Population, housing, income, employment, land use, master plans, zoning and environmental data are prepared and collected. Staff is available to explain how the land is being used, where the wetlands and sensitive ecological areas are, soil conditions, population trends, ethnic makeup, median or per capita incomes and sewer locations.

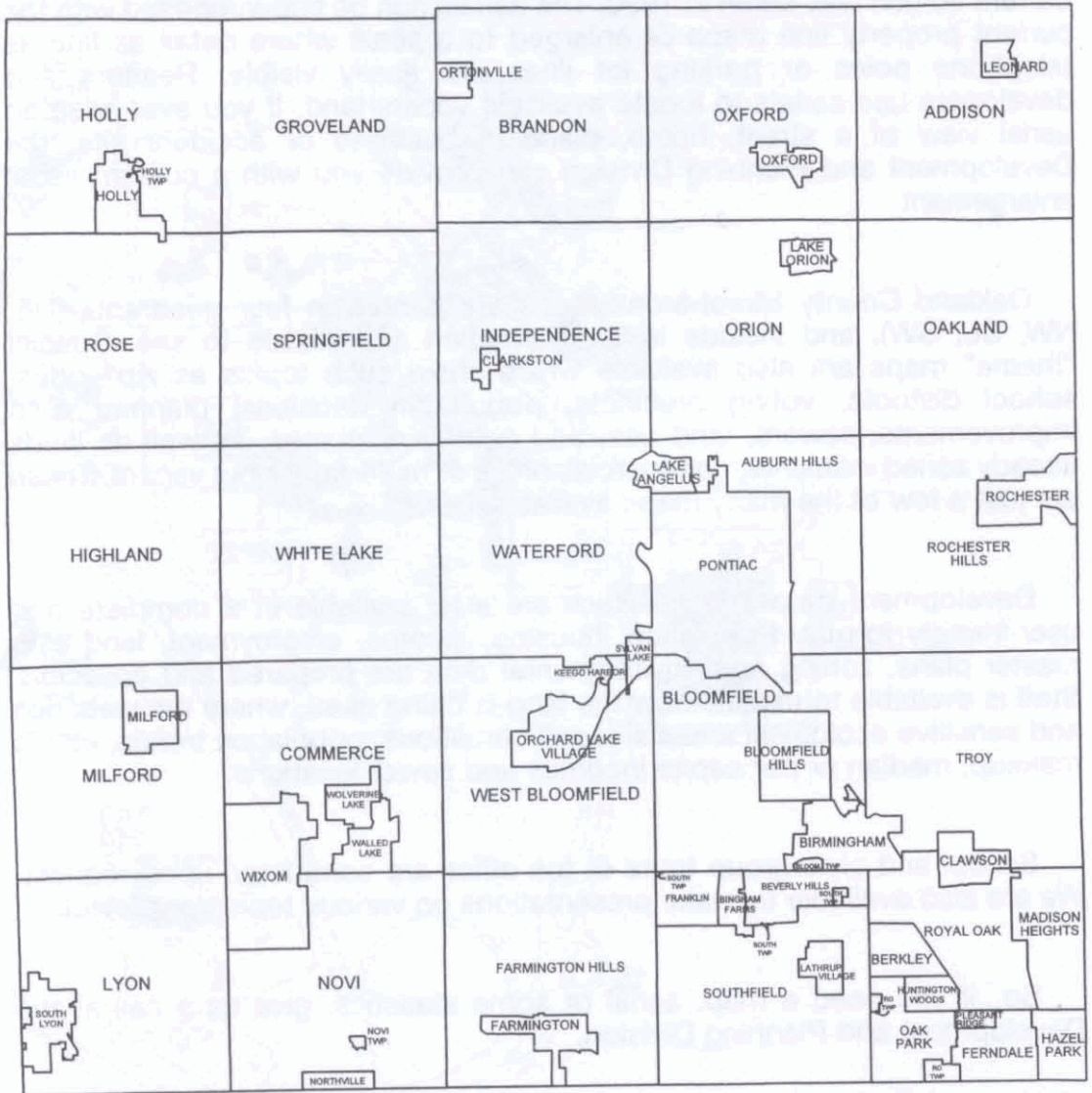
School and civic group tours of the office are conducted upon request. We are also available to make presentations on various topics or projects.
