### Minor league baseball planned for Lyon Twp.

Charter House of Novi resident turns 100

#### By James Mitchell STAFF WRITER

A minor league baseball team might throw its first pitch in 2005 lined up investors to build a sta-dium along I-96 on property cur-rently owned by Kensington Metropark.

A meeting to put the package together could happen this weekend.

Last month, minor league baseball commissioner Bill Lee told Lyon Township officials and local investors that, if a stadium is built, the Frontier League will bring a tearn to town. Community

interest and investor participation is preparing to make that field more than just a dream. "The ownership team is com-ing together with the intention of breaking ground in 2004 for the 2005 season," said Charile Robertson, Director of the South Lyon Area Chamber of Commerce. "I've always thought this world come together." this would come together." While Robertson declined to

while kobertson declined to cite the specific investors, she noted that South Lyon and Lyon Township government officials had been working with the Huron-Clinton Metropolitan Authority for land acquisition in Lyon Township.

Many parents overestimate children's street-cross-ing skills. The pedestrian skills of children are limit-ed by several factors related to their physical size and developmental stage. For instance, young children may lack the physical ability to cross a street quick-ly, and their small size limits their visibility to driv-or. ers

Children are likely to choose the shortest rather than the safest route across streets, often darting out between parked cars. In addition, young children do not evaluate potential traffic threats effectively, cannot anticipate driver behavior, and process sensory
