### SESSIONS OF THE OAKLAND COUNTY BOARD OF SUPERVISORS

Annual sessions of the Board of Supervisors are held on the Tuesday following the second Monday of April, on the fourth Monday of June and on the third Monday of September. A regular session may be held in January of each year by the adjournment of the September Session to a date certain in January.

RULE XXXII - In addition to the statutory meetings of this Board: (a) There shall be a regular meeting of this Board at ten o'clock A. M. on the Friday preceding the second Monday in May at which time the Board of Supervisors shall submit a "Tentative Budget for Allocation Purposes" and refer same to a joint meeting of the Salaries, Appropriations and Ways and Means Committees, which Committees shall meet preceding the meeting of the Board of Supervisors provided for in Section (b) below.

(b) There shall be a regular meeting of this Board at ten o'clock A. M. on the Friday preceding the first Monday in June at which time the Board of Supervisors shall approve a "Final Budget for Allocation Purposes", which budget shall be submitted by the joint Committees mentioned in Section (a) above. The Chairman of the Ways and Means Committee shall act as Chairman of the Joint Committees; however, if a majority of the personnel of any of the three committees does not concur with the joint committee report, the Chairman of that Committee shall present to the Board of Supervisors a minority "Joint Committee Report" pointing out the reasons for nonconcurrence and the Board of Supervisors shall thereafter dispose of the matter according to its judgment.

Special sessions of the Board may be called by a request of at least one-third of all Supervisors, which request must be filed with the County Clerk at least fifteen days before the meeting.

WHEREAS, the County of Oakland is the owner of property in the Township of Springfield which was deeded to the County by Manley Davis, pursuant to deed recorded in Liber 749 of Deeds, page 182, which property has been known as the County Park since 1926, the date of the deed, and

WHEREAS, pursuant to the provisions of said Deed the County was required to operate a park and/or golf course, said terms 'park' and 'golf course' being defined in the Deed to be synonymous, and

WHEREAS, the management of said Park has for many years been vested in the Road Commission and has been, in the opinion of many members of this Board, an unwarranted expense due to the fact that little use is made of the park, and

WHEREAS, the park is in a rather run-down condition, and

WHEREAS, the Township of Springfield has by resolution, a copy of which is attached to this resolution, requested the County to convey the park to the Township so that the Township may keep the same up so that it might be of use to the people in the immediate territory at least,

NOW THEREFORE BE IT RESOLVED that the request of the Township Board of Springfield Township be granted; that the Chairman and Clerk of this Board be authorized to Quit-Claim the property described in the Deed above referred to, to the Township of Springfield.

TO THE HONORABLE BOARD OF SUPERVISORS

OAKLAND COUNTY, MICHIGAN

WHEREAS, on October 16, 1935 and on November 8, 1935, the Board of Supervisors of Oakland County approved plans for the refunding of the principal of all outstanding and unpaid Covert Road bonds and for the adjustment of the unspread assessments pertaining thereto, which said bonds were issued and which said assessments were made by and under the jurisdiction of the Board of County Road Commissioners of Oakland County and of the State Highway Commissioner of the State of Michigan, respectively, and

WHEREAS, on certain other dates subsequent to October 16, 1935 and November 8, 1935, plans were approved by the Board of Supervisors of Oakland County for the refunding of certain of these bonds a second time, both as to bonds issued by the Board of County Road Commissioners of Oakland County and of the State Highway Commissioner of the State

of Michigan and

WHEREAS, under each of the refunding plans so approved there was provided an annual tax spread in each of the years from the date of such refunding plan to and including 1957 for principal and/or interest on unspread Covert Road

assessments existing at the time of approval of said refunding plans, and
WHEREAS, in accordance with act 150, P. A. 1927, as amended, (commonly known as the Gas Tax Act) and Act 302, P. A. 1915, as amended, (commonly known as the Weight Tax Act), certain moneys are returned to the County of Oakland for the reduction of Covert taxes and assessments spread under authority of Act 59, P. A. 1915, as amended, and/or in accordance with said refunding plans heretofore approved, and

WHEREAS, provision is made in each of the above numbered Acts, No. 150, P. A. 1927 and No. 302, P. A. 1915, both as amended, for the application of such money to a reduction pro rata of the amounts of the assessment installments becoming due in accordance with Act 59, P. A. 1915, as amended, upon property within said assessment districts, upon townships assessed as such, upon cities assessed as such and upon the county assessed as such, in proportion to the amount of assessments and taxes as originally spread, said allocation to be determined by the Board of Supervisors; provided, however, that the Board of Supervisors may increase or diminish the amount allocated to any district, city or township, or to the county at large, if it so determines such change to be necessary, said determination to increase or diminish said amount to become effective only upon approval by the state administrative board after due notice by the Board of Supervisors to the County Road Commission and to the governing body of any township or city where the allotment prescribed herein is changed by such determination, and

WHEREAS, in accordance with certain resolutions heretofore passed by this Board and approved by the State Administrative Board, it was determined that the money available for the reduction of Covert Road taxes spread in the years 1935 to 1949, both inclusive, should be used (1) to the reduction of Covert Road assessment installments to be spread against the property in the several assessment districts, (2) to the reduction of Covert Road assessment installments to be spread against the several townships and cities at large and (3) to the reduction of Covert Road

assessment installments to be spread against the county at large, and

WHEREAS, the liens remaining against the county at large, against the several townships and cities at large and against the several parcels or property in the various assessment districts, have now been reduced to a point where it appears that there will be sufficient of the so-called Gasoline and Weight Tax money in the years of 1949 and 1950

to satisfy in full all of the foregoing liens.

NOW THEREFORE BE IT RESOLVED, that all moneys returned to Oakland County in the years 1949 and 1950 for the reduction of Covert Road taxes or assessments under Act No. 150, P. A. 1927, as amended, and Act. No. 302, P. A. 1915, as amended, remaining after the payment of the 1949 installment (allocation for which has previously been approved), be used for the reduction of Covert Road liens in the following order of priority:

(1) For the reduction of liens remaining against the various parcels of property in the several assessment districts.

(2) For the reduction of liens remaining against the several townships and cities at large.

(3) For the reduction of liens remaining against Oakland County at large.

AND BE IT FURTHER RESCLVED, that the Ways and Means Committee of this Board be, and it is hereby authorized to make application to the State Administrative Board for its approval of such allocation of the so-called Gasoline and Weight Tax moneys and to give due notice in behalf of this Board of Supervisors of the hearing thereon.

If expressions may epitomize personalities, then of Luther Allen we may well say, "still waters run deep". He was a quiet, humble, self-effacing man. He was kindly but firm. He was public spirited and an honored and respected citizen. Those who knew him well, loved him. By his daily contact with his fellow men he builded in their hearts a shrine which will live as long as they live.

LET IT BE KNOWN:

That Luther Allen was born December 16, 1867 in Bloomfield Township;

That he married Anna Buttolph of Troy Township, November 26, 1890. Death separated them in 1944; That he helped organize the Village (now City) of Bloomfield Hills in 1926, was the first President and in the eighteen years of the Village's life, never missed a Council meeting;

That his faith in good roads stemmed first from his being Highway Commissioner in Bloomfield Township in 1894 and climaxed in his service to Oakland County where he served as Road Commissioner from January 1, 1925 until his death on Tuesday afternoon May 24, 1949;
That he was Chairman of the Road Commission for nine years, 1928-29, 33-35, 36-41, 42-47 and 1948.

Luther Allen has joined that innumerable caravan from which no traveler returns. Some day we too shall follow in his footsteps. Our journey shall be lighter for his having gone before for he will be humbly serving others wherever he is. Service was his motto and loyalty his creed.

WHEREAS, the Common Council of the City of Detroit did, on April 5, 1949, approve the report on 'Airports for the Detroit Region' excepting from approval the proposed Belle Isle Landing Strip and making said approval contingent

on the stated principles on the proposed International Airport and the completion of the Detroit-Wayne Major Airport

as contained in the previous resolution of February 2, 1949; and

WHEREAS, the Oakland County Board of Supervisors does hereby endorse the opinion of the Detroit Metropolitan Aviation Authority and the Common Council of the City of Detroit that the negotiations and plans for the development and construction of the proposed International Airport should proceed forthwith and that it is of paramount importance that the construction and improvement of the Detroit-Wayne Major Airport shall in no way be curtailed or delayed but shall be, as expeditiously as possible, completed as planned to assure Federal aid and provide for immediate use a major all purpose airport for this region;

NOW THEREFORE BE IT RESOLVED that the Board of Supervisors of the County of Oakland does hereby approve the following five points of the report on 'Airports in the Detroit Region' with the provisos as set forth in this

resolution:

1. A Major Airport - the International Airport shall be constructed on a site near Windsor, Ontario, as a

major passenger terminal.

- 2. The Detroit-Wayne Major Airport shall be improved to major airport status designed to function as an air-cargo airport and as a passenger terminal serving the entire region. (Without regional use restriction as suggested in the original report)
- 3. Willow Run Airport should continue to be operated as an aeronautical research and educational facility.

  4. The Detroit City Airport shall be improved (though without major expansion) to provide greater service to commercial aviation, itinerate pilots and industrial users of company-owned aircraft.

5. The Pontiac Municipal Airport shall be expanded to provide northwesterly sections of the region with local or feeder type air passenger mail and cargo service.

BE IT FURTHER RESOLVED that this Board of Supervisors concurs in and approves the determination of the Detroit-Metropolitan Aviation Authority and the Common Council of the City of Detroit that there is a need for the development of both the proposed International Airport and the Detroit-Wayne Major Airport and the City of Pontiac Airport to service the air transportation needs of this region thus requiring the immediate completion of the Detroit-Wayne Major Airport as planned and the Pontiac Municipal Airport and the immediate negotiation and planning of the proposed International Airport so that its actual construction may be realized; and

BE IT FURTHER RESOLVED that the Michigan Aeronautics Commission be, and it hereby is, requested to use its power and authority by taking such actions as will facilitate the immediate completion of the Detroit-Wayne Major Airport and the Pontiac Municipal Airport as planned and expedite the negotiations, planning and ultimate development

of the proposed International Airport; and

BE IT FURTHER RESOLVED that copies of this resolution be sent to the Detroit Metropolitan Aviation Authority, Macomb County, the Michigan Aeronautics Commission, the Honorable Arthur Reaume, Mayor of the City of Windsor, the Federal Civil Aeronautics Administration and the Common Council of the City of Detroit.

TO THE HONORABLE BOARD OF SUPERVISORS:

Your Building and Grounds Committee, pursuant to reference from this Board, has had under consideration, the matter of appraisal of the Court House in connection with the letter previously received.

We are informed unofficially, but we believe somewhat reliably, that from the standpoint of business desir-

ability, the Court House property is worth about \$350,000.00, not more than \$400,000.00.

Your Building and Grounds Committee met on the fifteenth day of July A. D., 1949, and had under consideration the request of Springfield Township for the conveyance to the Township of the so-called County Park in said Township.

We considered the reservation in the original grant recorded in Liber 749 of Deeds on page 182 and after consultation with Mr. Merritt are of the opinion that the lands south of the Andersonville Road are free from any reversionary claim on the part of the County's grantors and such lands are not now and never have been used for Park purposes, being at present rented to a private person. We see no reason why these lands south of the road should be conveyed to the Township.

The lands north of the road have been used for park purposes ever since the grant was made to the County and are, at present, being so used. Immediate control of the said lands has been vested in the County Road Commission for several years and the entire Committee was of the opinion that it would be advisable to deed such lands to the Township in Trust for the use and benefit of the people of Oakland County, subject to the township maintaining said lands consistent with the conditions imposed by the original grant to the County.

At our request the Corporation Counsel has prepared a Deed to such lands, which I hand you herewith, and on behalf of the Committee I move that the Chairman and Clerk of this Board be authorized to execute the Deed as drawn,

and deliver the same to the Township of Springfield. I move the adoption of this resolution.

Gentlemen:

The matter of the death of George Bearden was referred to the Sheriff's Committee for investigation.

Your committee has investigated the circumstances surrounding the death, and report as follows:

We find that Ted LaPointe and Gordon Hodges, Sr. are special deputies not on the Sheriff's payroll. Ted

LaPointe is a special deputy, without pay, and Gordon Hodges, Sr. an employee of the Probate Court with no particular

assigned hours of employment;

That Delos Anderson and George Bearden, special deputies working on detective work with definite working hours, however, they could not be strictly held to specific hours because they were on call at any hour. In this particular instance, we find that there was an accidental meeting of these men and the Sheriff, who invited them to the cottage. They had no intention of going there until they received a radio message to call Marion, Ohio police by phone, which they then decided to do from the Sheriff's cottage.

Upon arriving there they were invited to take a ride in the Sheriff's boat where the accident happened.

We also find that Undersheriff Don Menzies was called by the Sheriff to bring out a trusty of the jail; this call being made before the accidental meeting of the Sheriff and Anderson and Bearden. We find that there was no pre-

arranged meeting intended by any of the men involved.

The matter of taking a trusty away from the jail for any reason whatsoever should not be approved and we therefore recommend that the Corporation Counsel render an opinion to the Sheriff's Department on handling of prisoners or trustys, in so far as it affects the liability of the county.

We also wish to report that the very nature of police work cannot hold all officers to regular hours because there have been times when the men are asked to work more than their regular shift, which was the fact in this case

because of the three day holiday of May 28, 29 and 30, 1949.

REPORT OF SPECIAL COUNTY PLANNING COMMISSION

To the Honorable Board of Supervisors of Oakland County:

Gentlemen:

In 1948 the question of adopting Act 282 of the Public Acts of 1945 was referred to the above named special

committee appointed by Chairman, Wm. C. Hudson.

Your Commission has spent some time considering this act and the wisdom of adopting it for Oakland County. In substance, the Statute provides for a County Flanning Commission of not less than five nor more than eleven members who shall be representatives of the Community. There are several other provisions in the Statute which cannot be detailed at this time. However, after a thorough discussion of all of the provisions of the act, we are convinced that it is for the best interests of Oakland County that the Board of Supervisors adopt act 282 of the Public acts of 1945.

We take this position because of the need for a central agency to coordinate and make plans for the future

We take this position because of the need for a central agency to coordinate and make plans for the future growth and development of the County as a whole. Many of the county problems are inter-related with problems of other local communities and on account of the extensive growth of the county the importance of water, sewage and land use and

development will become more acute every day.

The Commission believes that the Planning Commission can be located in the office of the County Drain Commissioner, Earl L. Clark and that there should be on the Committee, the following County Officials: Corporation Counsel, Drain Commissioner, Engineer-Manager of the Road Commission as well as a representative from the Huron-Clinton Park Authority. The remaining members will be appointed by the Chairman of the Board in the event this report is adopted.

The act also further provides that the provision must be made for the method of selecting the Members of the Planning Commission and we would recommend on this point that the Chairman of the County Board of Supervisors appoint such members in the first instance including the above named officials and that, on all further appointments, including vacancies, that the same shall be made by the Chairman of the County Board upon consultation with the remaining members of the Planning Commission. This is suggested for the reason that the remaining members of the Commission should be in a better position to know who would have the knowledge, experience and interest in the work of the Committee so it would function properly for the benefit of the County.

An examination of the Planning Act work performed in Washtenew County is, in our judgment, proof of the value of this activity in the county affairs. The Washtenew County Planning Commission has performed an excellent work of public service and we are of the opinion that a Committee set up for Oakland County could do the same work for Oakland.
