SESSIONS OF THE OAKLAND COUNTY BOARD OF SUPERVISORS

Annual sessions of the Board of Supervisors are held on the Tuesday following the second Monday of April, on the fourth Monday of June and on the third Monday of September. A regular session may be held in January of each year by the adjournment of the September Session to a date certain in January.

RULE XXXII - In addition to the statutory meetings of this Board: (a) There shall be a regular meeting of this Board at ten o'clock A. M. on the Friday preceding the second Monday in April at which time the Board of Supervisors shall submit a "Tentative Budget for Allocation Purposes" and refer same to a joint meeting of the Salaries, Appropriations and Ways and Means Committees, which Committees shall meet preceding the meeting of the Board of Supervisors provided for in Section (b) below.

(b) There shall be a regular meeting of this Board at ten o'clock A. M. on the Friday preceding the first Monday in May at which time the Board of Supervisors shall approve a "Final Budget for Allocation Purposes", which budget shall be submitted by the joint Committees mentioned in Section (a) above. The Chairman of the Ways and Means Committee shall act as Chairman of the Joint Committees. However, if a majority of the personnel of any of the three Committees does not concur with the joint Committee report, the Chairman of that Committee shall present to the Board of Supervisors a minority "Joint Committee Report" pointing out the reasons for nonconcurrence and the Board of Supervisors shall thereafter dispose of the matter according to its judgment.

Special sessions of the Board may be called by a request of at least one-third of all Supervisors, which request must be filed with the County Clerk

at least fifteen days before the meeting.

In accordance with our previous conversations, this is to notify the Board that, effective January 1, 1950, the charges for County patients at the Pontiac General Hospital will be on a standard rate basis based on ward rates. The County will be billed for the lowest rate room plus all service and medical charges. No patients will be placed in a room at a higher rate without direct authority through proper channels from the Welfare Board.

For your information, in making up next year's budget, seven months of operation at the Hospital indicates

that the amount of additional money to be paid to the City under present conditions is approximately \$15,000.00.

We wish to assure you that we will do everything in our power to cooperate and hold the County costs as low as possible under the above arrangements.

TO THE BOARD OF SUPERVISORS OF OAKLAND COUNTY

GENTLEMEN:

Your Ways and Means Committee, charged with the duty of presenting to this Board a budget for the operation of the County for the fiscal year starting January 1, 1950 and ending December 31, 1950, respectfully submits the

Budget hereto attached and by way of explanation thereof states as follows:

The report of the Salaries Committee and of the Appropriations Committee, copies of which were supplied to the Ways and Means Committee, have been duly considered and this Committee presents the Budget, above mentioned, having in mind the principle that appropriations and operating expenses should be in a sufficient amount to be consistent with the demands of each Department and ample enough to make over-drafts unnecessary. The amounts placed after the respective items in the Budget have been arrived at by reference to the recommendations of the Departments and the Board of Auditors and consideration has been given to past experience as well as probable requirements for increase in service during the fiscal year the Budget covers.

We recommend the continuance of the policy to have the Board of Auditors divide the Budget of each department into four equal parts and, as soon as possible after the close of each quarter, mail a copy of the financial status to all members of the Board of Supervisors and to each Department Head, the statement showing the amount of money allocated for the stated quarter, the amount expended and the balance or overdraft as the case may be, together

with a suitable summary of each department.

We recommend that each County official and each County employee be given two weeks vacation during the

calendar year of 1950 and receive their regular wage or salary during the vacation period.

We recommend that in all cases where statutory holidays fall on, or by Statute, are celebrated on Monday, that all County Offices be closed from five o'clock the preceding Friday until 8:30 Å. M. the following Tuesday. We recommend that in the Institutions, such as hospitals, etc. where part of the help must work on the days contemplated in the preceding sentence that the Department Heads arrange an equivalent amount of time off as soon as possible after said holidays for such employees.

We recommend that the salaries herein provided for be in lieu of all fees, which fees shall belong to and be

credited to the General Fund.

We further recommend that \$12,913.30 of the Contingent Fund be earmarked for the County-at-large portion of

the Clinton River Spillway.

Inasmuch as the Detroit Metropolitan Area Regional Planning Commission appeared before the Ways and Means Committee relative to their request for an appropriation and did not appear before the Appropriations Committee, we make no comment thereon other than to refer the entire matter to the Appropriations Committee and, in the event that Committee recommends an appropriation which is approved by this Board, that the amount of the appropriation be taken from the Contingent Fund.

We further recommend that any Department Head who makes any unauthorized purchases shall be held strictly

accountable therefor.

TO THE OAKLAND COUNTY BOARD OF SUPERVISORS:

Pursuant to Miscellaneous Resolution of August 9, 1949, this Board referred to the Ways and Means Committee the matter of advertising for and recommending to this Board the names of persons qualified for the position of County Auditor.

An appropriate advertisement was prepared and carried in the Pontiac and Royal Oak papers. Application forms were made available at the Auditor's Office and twenty applications were received. Of these twenty, this Committee recommends for the Board's consideration the three persons who will later be named.

In making this recommendation it should be clearly understood that there is no reflection on the rest of the twenty not recommended. The applicants were an exceptionally well qualified group. However, this Committee felt that someone should be selected whose age would enable him to be of service to the County for a long period of time and

with that and the County's Retirement Plan in mind, we arbitrarily eliminated all applicants over fifty years of age.

We also eliminated from consideration all supervisors. We did this because they, at the date of this recommendation are ineligible for appointment under the Auditor's Statute and we did not want to recommend anyone who was ineligible.

We also eliminated from consideration those persons who represented on the questionnaire that they had no party affiliations. We could not recommend a Republican as there are now two Republican members and we know we are not violating the law when we eliminated from consideration those who did not declare their affiliation.

At the expense of repetition, we again say that, with no reflection on any of the other applicants, this

Committee recommends for your consideration:

1. Edson T. Doolittle, Route 7, Pontiac, Michigan

2. Leslie H. Hudson, 796 Tyrone Street, Pontiac, Michigan 3. Norman A. Morgan, 328 East Liberty, Milford, Michigan

In view of the fact that this appointment is political and the report of this Committee may, with propriety, be completely disregarded by the Board, we sent to each applicant a copy of this report so that each would be apprised of the Committee's recommendation and be able to act accordingly.

Since passing the foregoing recommendation, it has come to our attention that the same Section of the Law which rendered incumbent Supervisors ineligible for the appointment applied to Township Officers as well. Consequently, you should ignore our recommendation on Leslie H. Hudson without prejudice one way or the other. To the Honorable Board of Supervisors:

Gentlemen:

In answer to the letter or petition read before this Board of Supervisors October 31, 1949 and referred to the Market Committee, the list of complaints and answers are as follows:

1. The debris or garbage is strewn.

Answer: Disposal of refuse after it is picked up is not the job of the Market Master.

2. Papers are left to blow.

Answer: All papers are picked up and put in containers.

3. Boys throw apples, tomatoes, etc.

Answer: We feel this is a problem of law enforcement.

4. Boys lie on top of buildings to see what they can hit with their guns. Answer: This also is a problem of law enforcement.

5. Flies by the millions.

Answer: We recommend that garbage be picked up promptly.

6. Fires are a hazard.

Answer: Prompt pickup of paper will eliminate fire hazard.

7. Drunks use both inside and outside of the building for toilet purposes.

Answer: Market Committee has no control over the drunks in the area.

8. Trucks have consistently mutilated fences.

Answer: There has been but one instance where a fence was mutilated and the Market Master watches this very closely. This area is also used for public parking.

9. Congestion from traffic is very annoying.

Answer: Moving the Market will not eliminate this condition as it is just as bad on Fridays as on market days.

10. Dog owners find the Farmers' Market a mecca in which to unleash their dogs at night.

Answer: Progress must go on.
11. Water is dumped into the alley causing bad holes.

Answer: We do not believe there is enough water used at the Market to cause holes in the alley.

SUMMARY:

The Committee realizes the Farmers' Market should be improved because it is both unsatisfactory to the neighborhood and the producers.

The present shed-type structures are dilapidated and in a condition unfit for market purposes.

The site offered by the City of Ferndale on East Nine Mile Road is neither suitable nor adequate.

We believe that the complaints listed above would be largely eliminated through the improvement of the market. We recommend that two shed-type buildings 100' x 44' be erected and paved, with a 12" raised center for display of produce, at a cost of approximately \$14,200.00 each - 60% by County and 40% by Ferndale City. This recommendation is subject to the approval of the Commission of the City of Ferndale.

FINANCIAL REPORT - DETROIT METROPOLITAN AVIATION AUTHORITY

November 14, 1949

Detroit Metropolitan Aviation Authority 1302 Cadillac Square Building Detroit 26, Michigan Gentlemen:

Your Finance Committee respectfully submits the following report on the Authority's request for appropriations for the 1949 fiscal year from the Michigan Aeronautics Commission, the Counties of Wayne, Oakland and Macomb.

The Michigan Aeronautics Commission

The Michigan Aeronautics Commission has included in its recommended budget to the Legislature an item of \$20,000 for the Detroit Metropolitan Aviation Authority. A notation on the budget reads as follows: "Providing the Counties of Wayne, Oakland and Macomb appropriate funds to match the State request".

Any monies appropriated by the State Legislature in its special session, which we understand will be called in February, will not become available until July 1 of 1950. However, it has been the policy of the Michigan Aeronautics Commission in the past to request permission from the State Administrative Board to advance sums of money within the recommended appropriation prior to the beginning of the State fiscal year.

It is our understanding that the Administrative Board has advised the Michigan Aeronautics Commission that

it will not in the future authorize any monies for the Detroit Metropolitan Aviation Authority.

Mr. Cass Hough, Chairman of the Michigan Aeromutics Commission has advised us that he will personally appear before the State Administrative Board and endeavor to prevail upon them to change their attitude relative to making monies available for the Detroit Metropolitan Aviation Authority.

Wayne County

The Wayne County Board of Supervisors, at its annual budget session held in October, 1949, denied the request of the Detroit Metropolitan Aviation Authority for an appropriation of \$20,000 for the 1949-50 Wayne County fiscal year. As there were only two dissenting votes on the Ways and Means Committee against this action and, as far as we know, no dissenting votes at the full session of the Board of Supervisors of Wayne County when the County budget was finally approved, there seems little likelihood that the Wayne County Board of Supervisors will change its attitude relative to this appropriation.

Oakland County

Oakland County has approved in its 1949-50 budget the requested appropriation of \$3,000. We understand, however, that unless there is assurance that Wayne County will provide its \$20,000 requested appropriation and the Michigan Aeronautics Commission provide its \$20,000 requested appropriation, there will be an inclination on the part of Oakland County to withhold its appropriation of \$3,000.

Macomb County

It is our understanding that Macomb County has refused to honor the request of the Detroit Metropolitan Aviation Authority for an appropriation of \$2,000 for the 1949-50 fiscal year.

Because of the aforementioned facts, the probability of monies becoming available from the Michigan Aero-

nautics Commission and the Counties of Wayne and Macomb is most unlikely.

The recent adoption by the Detroit Common Council of an ordinance creating a Detroit Aeronautics Commission, though not yet approved by the Mayor of Detroit, and the fact that the Michigan Aeronautics Commission has expressed itself informally that it is willing, upon invitation, to continue to render to the Metropolitan Area, through its staff, any services that may be required in the future of the Detroit Metropolitan Aviation Authority undoubtedly will be influencing factors in any future action pertaining to appropriations for the continuation of the staff functions of the Detroit Metropolitan Aviation Authority.

Your Finance Committee views with apprehension the bleak outlook for continued appropriations to enable the Detroit Metropolitan Aviation Authority to continue its staff functions. However, in our opinion, this does not necessarily mean the discontinuance of the Detroit Metropolitan Aviation Authority as a planning authority. With the assistance of the Michigan Aeronautics Commission, we feel that the Authority can continue to render a necessary function in airport planning without cost to the counties comprising the Detroit Metropolitan Aviation Authority.

With the small balances which are still available for the Authority, it seems reasonable to expect that the agency can continue for several months. In fact, with a reduced payroll and proceeding merely as a planning agency,

a job of considerable merit can still be accomplished.

Recently an ordinance has been adopted by the City of Detroit to establish an Aeronautical Commission who are charged with operating of any city airports which exist and the promotion, acquiring, building and operating of others—with special emphasis on the Windsor site—so that the responsibility for continuing the activities of which this Authority has devoted most of its time no longer exists.

WHEREAS, the Committee has investigated the matter thoroughly, and

WHEREAS, if the present Juvenile Building is so converted it will involve the construction of at least three units of four cottages each to handle the present Juvenile load with the probability of expansion necessary before the Juvenile Building could be used in connection with the Infirmary, and

WHEREAS, the Committee cannot, at the present time, see any way clear to finance such a large program, and WHEREAS, conversion of the Juvenile Building would provide at most about eighty-five beds, which is not a complete solution to the congestion problem in the Infirmary and two additional wings would be necessary to provide the present needed bed capacity with a small amount for expansion at an estimated cost of \$691,585 for the two wings which, with the conversion of the Juvenile Building approximating \$116,756.00 would amount to \$808,341.00;

NOW THEREFORE your Building and Grounds Committee respectfully reports to this Board that the Committee deems it inadvisable, at the present time, to proceed further with the suggested conversion of the Juvenile Building

to a hospital facility.

GENTLEMEN:

With reference to the case of a widow and four children which was referred to at the meeting of the Board of

Supervisors on October 25, 1949, you will find below a resume' of our case as to the family's needs.

September 14, 1949: Woman made application for assistance. Man had passed away September 6, 1949. There was no insurance. The family purchased a home in March 1948 for \$9500.00. At the present time, the balance on the contract is \$6836. Interest payments were paid to date. A small cottage located at the rear of their lot is rented to woman's sister at \$35.00 per month. Woman also owned a 1947 Plymouth car with a balance of \$1007.00 owing. She planned on keeping the car for her personal use. It was explained to her that this department would insist upon her applying to the Bureau of Social Aid for an Aid to Dependent Children grant, and when this application was made, the grant would be refused if she retained the car because of its value. Woman phoned and advised she had sold the car and had received sufficient money to pay the October house payment and a personal debt which she owed. Woman has applied for Social Security Benefits under the Old Age & Survivors Insurance Plan and this department requested her to make immediate application for an A.D.C. grant.

September 15, 1949: A home call was made. Our worker again interviewed woman and compiled the necessary budget from the information obtained at that time. Subsequently woman has received Social Security Benefits in the amount of \$42.00 per month. Her total income at present amounts to \$77.00 per month. Woman requested glasses for her son. She was referred to boys' school where arrangements were made for eye examination and glasses. At the time of woman's application she advised she was leaving her children with her sister and was going to Illinois for a visit at

the home of her aunt. Monthly budget for family was worked out as follows.

Provision Order 33.00 This department furnishes food, milk, baby food, fuel, clothing, medical Milk 12.00 Baby Food 4.00 expense as needed, gas, light and *Cooking gas 2.50 water. *Electric 3.25 *Wa ter 3.60 This allows woman to make her full 15.00 *Fuel \$75.00 payment on her house from her Shelter 75.00 \$77.00 per month income. For the *Clothing 10.00 month of October the \$77.00 was clear as house payment was made from monies *Household Necessities 5.00 *Real Estate Taxes 9.00 received from sale of the car. 8.33 *Life Insurance Premiums 2,25 \$182.93 Sales Tax TOTAL BUDGET: *NOTE: These items are allowed Less: Income 77.00 on an actual needs basis. \$105.93 Deficit:

Above case was continued on this basis until December 12, 1949 when woman received her first A.D.C. grant in the amount of \$116.00. She also received Social Security of \$52.10 per month and \$35.00 from the rent of the house at the rear of the lot. The oldest boy has a paper route and his earnings are from \$8.00 to \$10.00 per week. Worker suggested to woman that she try to refinance her home so that her payments would be lower and she is going to attempt this. As our budget figures \$182.93 per month and woman's income is now \$203.00 per month, the case has been closed by this department.

Oakland County Department of Social Welfare

Note:

Not doubting the case-worker's visits to this particular family, I, as Chairman of the Welfare Committee, have made two or three visits in the home, not to discredit the case-worker's activities in compiling this report but merely to substantiate the report since it was brought up before the Board of Supervisors. I can conscientiously state to you the report is a very complete one and the family involved is completely satisfied.

Misc. 2528. By Mr. Leavy: TO THE BOARD OF SUPERVISORS: GENTLEMEN:

Your Special County Clerk's Committee has made a survey of the County Clerk's Cffice to determine the impact of the Act passed by the 1949 Legislature covering registration and re-registration of persons using an Assumed Name. We find that this Act will quite substantially increase the fees collected by the Clerk's Office - \$27,000.00

is the estimate. However, there is a tremendous amount of detail work in getting out the required notices and to

comply with the Act in all particulars.

After discussion with Mr. Allen, your Committee is of the opinion that it will take some experienced Clerk at least six months to complete the work involved and we recommend that an additional \$1200.00 be appropriated to supplement the Clerk's present budget to make possible the employment of such Clerk.

Mr. Chairman, I move that this matter be referred to the Ways and Means Committee and that they be empowered

to act if the money is available.
