SESSIONS OF THE OAKLAND COUNTY BOARD OF SUPERVISORS

Annual sessions of the Board of Supervisors are held on the Tuesday following the second Monday of April, on the fourth Monday of June and on the third Monday of September. A regular session may be held in January of each year by the adjournment of the September Session to a date certain in January.

Special meetings of the Board may be called by a request of at least one-third of all Supervisors, which request must be filed with the County Clerk at least fifteen days before the meeting.

RULE XVIII. (a) At the statutory meeting of this Board held on the Tuesday following the second Monday in April of each year, the Board of Auditors shall submit to the Board of Supervisors a "Tentative Budget for allocation purposes" and the Board of Supervisors shall refer the same to a joint meeting of the Salaries, Appropriations and Ways and Means Committees, which Committees shall meet preceding the meeting of the Board of Supervisors held on the third Monday in April, viz: the deadline for filing the final allocation budget with the County Tax Allocation Board.

(b) There shall be a regular meeting of this Board at ten o'clock A.M. on the Friday preceding the third Monday in April at which time the joint committees referred to above shall consider their report to this Board with the recommendations on the adoption of the final allocation budget to be acted on the following Monday. The Chairman of the Ways and Means Committee shall act as Chairman of the joint Committees; however, if a majority of the personnel of any of the three committees does not concur with the joint committee report, the Chairman of that Committee shall present to the Board of Supervisors a minority "joint committee report" pointing out the reasons for nonconcurrence and the Board of Supervisors shall thereafter dispose of the matter according to its judgment.

Clerk reads letters from Ferndale City, Royal Oak Township and Clawson City endorsing and approving a \$15,000.00 appropriation requested by the Oakland County Planning Commission. (Referred to Appropriations Committee by Chairman.)

#### REPORT OF COUNTY PLANNING COMMISSION

Pursuant to the request of the Board of Supervisors at the last meeting of the Board held on the 26th day of June, 1950, the County Planning Commission hereby submits the following report:

Act 282 of the Public Acts of 1945 authorizes the creation of a County Planning Commission of not less than five members nor more than eleven members.

This Board appointed a Committee consisting of Perry Vaughan, Evert M. Bangham, Wm. A. Ewart, Earl L. Clark and Harry Merritt to study the Act and recommend to this Board as to whether or not a County Planning Commission should be formed. This Committee reported favorably to this Board on the 9th of August 1949, and, on the 25th day of October 1949, this Board of Supervisors appointed the following personnel to the County Planning Commission: Harry J. Merritt, Earl L. Clark, R. Clare Cummings, George Schmid, Robert Swanson, Ernest Seaholm, George J. Bery, Leon Hubbard, Adsit Stewart and Leon Belknap.

The County Planning Commission, hereinafter called "The Commission", met for organizational purposes on the 2nd day of November, A. D. 1949 and, at that time, Harry J. Merritt was elected Chairman, Adsit Stewart was elected Secretary and the general functions of such a Commission were discussed. It was felt at that time that there was little a County Planning Commission could do until the work of the Detroit Metropolitan Area Regional Planning Commission had progressed further and the Commission recommended participation by the County of Oakland in support of the Metropolitan Area Regional Planning Commission, which support this Board gave.

A second meeting of the Commission was held on the 22nd day of March 1950 at which the details of Act 282 were discussed and the members more or less familiarized with the contents of the Act 282.

This meeting was attended by representatives of the Detroit Metropolitan Area Regional Planning Commission, hereinafter referred to as "The Regional Commission" and ways and means discussed as to the manner in which the Planning Commission could be most helpful to the various units in the County with their local plans. Mr. Blakeman and Mr. Edmonson, from the Regional Commission, were present at this meeting and presented several maps which had been prepared by them which were pertinent to the interests of both Commissions. These maps were primarily land use maps. All of the available Zoning Ordinances of the municipalities in Oakland County have been accumulated for reference and each member of the Planning Commission has been supplied with a publication entitled "Zoning and Civic Development" which is published by the Chamber of Commerce of the United States. This pamphlet is background material to acquaint the members of the Commission with some of the basic essentials which would be involved in County planning.

The Commission held a third meeting on August 4, 1950 at which meeting, the primary subjects of discussion were pollution and highways. The Regional Commission prepared for the County Planning Commission a map showing the area in Oakland County outside of the Southeastern Oakland County Sewage Disposal System, for which area a natural sewage disposal treatment point is the Sewage Disposal System of the City of Detroit. This map discloses the trunk line sewers in the City of Detroit which are available for transmission of sewage in the Southfield area, concerning which a suit is now pending by the City of Detroit to prevent pollution. In connection with this map, the Drain Commissioner's office, in cooperation with the Regional Commission, laid out the necessary interceptor sewer lines to service the area adequately and the Drain Commissioner's office estimates that approximately three million dollars would be involved in this project. Whether or not the area has enough resources to justify such a program is not known and the Commission will make a survey to ascertain that fact in the future.

The matter of pollution in our lakes, particularly in the area west of Pontiac, the Commission feels should be given study with the object in mind of a permanent solution before the problem becomes aggravated to too great an extent. The Commission feels very strongly that we should do everything in our power to preserve the purity of our lakes in order that these natural resources may be passed along to the future generations clean and unpolluted.

The matter of highways was discussed and Mr. Belknap, a member of the Commission, who was present, explained that they were unable to supply maps at the present time, lacking the personnel. However, detailed over-all plans would be made and presented to the Commission at the earliest opportunity. This may be from three to six months.

The Commission is unanimously of the opinion that a technician with background planning training should be employed and furnished with a full or part time secretary and perhaps a draftsman to take the necessary time to become fully advised as to the activities and work of adjacent areas in which planning is in progress so that the County plan may be coordinated with periphery units and particularly the organization formed in the southern part of the County which has been doing some active planning work. A Committee was appointed by the Chairman on resolution of the Commission, which committee was composed of Robert Swanson, Ernest Seaholm, George J. Bery and George Schmid to search for available material for the position.

In order to hold our expenses at a minimum, the Commission passed a resolution requesting that \$15,000.00 be placed in this fall's budget to employ the minimum personnel and further recommended that this Board of Supervisors continue its contribution to the Regional Planning Commission in addition to the employment of the local planner. The Commission feels that this money wisely spent will result in ultimate savings to the County and the infinite welfare of the County in the future.

Leon Hubbard, one of the members of this Commission, tendered his resignation because of business reasons and it is the recommendation of the Planning Commission that the resignation be accepted with regrets and this Board fill the vacancy created by his resignation.

This report is respectfully submitted and it is recommended that it be made a part of the minutes of this meeting.

TO THE HONORABLE BOARD OF SUPERVISORS:

Your Equalization Committee to which was referred the matter of additional assistance in equalization, wishes to report.

The majority of the members of the Equalization Committee have been of the opinion for several years that one or more field men working throughout the year, under the supervision of the Equalization Committee, could gather factual information which would enable the Committee to effect and maintain a more equitable equalization than under the present procedure. The advisability of such information seems to be much more important since the recent unpleasant incident in the case of Southfield Township.

Supervisors Minutes Continued. September 18, 1950.

Your Committee has had a conference with Albert Chapney of the Wayne County Bureau of Taxation and he rehearsed their experiences. It is his opinion that we should employ one field man to check personal property and one field man and an assistant to check real property, all under the direction of the Equalization Committee. This would enable the Board of Supervisors to effect a much more equitable equalization report. This would also point out to the various assessors where they could improve their individual assessments and bring in many times more tax revenue than the cost of their services.

The annual cost of this program is estimated as follows:

One man for real - \$6000.00 - Head of Department.

One man associate - \$5000.00 - for personal.

Two part time helpers and miscellaneous \$7000.00.

Department to be under the jurisdiction of the Equalization Committee.

Equalization Committee to meet with Department regularly and direct their work of securing the necessary information.

Compile their records in proper form.

The above is the recommendation of the following members of the Equalization Committee who respectfully request that due consideration be given same before final completion of the budget for the ensuing year.

At a meeting of the Commissioners of the State Tax Commission held in the County Courthouse in the County of Oakland, on Tuesday, the eleventh day of July, A. D. 1950.

Present: Chairman Louis M. Nims and Commissioner Clarence E. Paddock.

On reading and filing the petition of Dudley P. Frame, a member of the Board of Supervisors of the County of Oakland, praying for a review of the equalization of the assessed valuations of the several assessing districts in said County of Oakland for the year 1950, as made by the Board of Supervisors of said county, and for an adjustment and revision of said equalization; and after hearing all testimony offered for and against said petition and after considering all information in their possession relative to said equalization, the said Commissioners of the State Tax Commission decided that the valuations of said County of Oakland have been improperly equalized by said Board of Supervisors for the year 1950.

Mr. Chairman:

I would like to bring before this Board some thoughts of our City Commission, as expressed by our Mayor Bruce D. Garbutt

Oakland County has long been the playground of the Metropolitan area and the southern part of the County is fast becoming the home of many thousands who earn their livelihood in the City of Detroit. South Oakland County is the sieve through which those people south of our County line filter out to our great playground areas and through which those people living in South Oakland County filter across the line into Detroit to their daily work.

Our local residential streets are becoming the through arteries which carry too large a portion of the flow of traffic. Our people, who came out here to get away from the noise and hustle of city traffic, are complaining that their streets which were once quiet and secluded, are now public thoroughfares, carrying a considerable volume of through traffic. They are carrying this traffic because Oakland County Highways are not adequate to carry this heavy load. They are not adequate because the existing pavements are so badly broken, pitted and rough. Traffic naturally seeks a smoother road to travel. Also, these roads are not wide enough to carry the extra volume of traffic they should.

We appreciate the circumstances that have brought about this condition. We know that, some twenty-five years ago, Oakland County saddled itself with a large Covert Road Bonding Program to build a highway system which, at that time, seemed quite adequate and complete. We realize that, through the depression, Oakland County took over the payment of these Covert Road Bonds and, by using a large portion of the Gas and Weight Tax coming to Oakland County through these years, the bonds have been paid off. We realize that the money remaining from the Gas and Weight Tax was not sufficient to adequately maintain these highways in their proper condition.

We are not, at this time, trying to place the blame for the condition of our highways on anyone or any group. Without a doubt, the Highway Commission has done the best job possible with the money at hand. We do realize that, at this time, we have suddenly found that we have a large highway system throughout Oakland County that is in a terribly run-down condition, to the end that most of our highways should almost be completely replaced or rebuilt. You all know the condition of our county roads. We further find that due to increased population trends and due to increased automobile ownership by this large increase in population, we have a traffic problem that is far beyond the capacity of these highways, even if they were in good shape.

We think that it is high time that some serious thought be given to what can be done to relieve this situation. We would like to remind you that the City of Detroit has developed a plan of express highways and they are spending millions to develop these highways which are going to add materially to our traffic problem in Oakland County. Furthermore, they are planning to complete a major portion of this system within the next four years. As far as we know, there has been no effort made to plan for this increase in traffic throughout our County. We believe that something must be done and it must be done now so that our highway system will be ready to meet that traffic load that will surely be thrust upon us and therefore, I would like to offer the following motion:

I move that our County Road Committee be instructed to meet with the Oakland County Road Commission and the Oakland County Planning Commission to give study to this problem and, at the next meeting of this Board, bring in a report showing:

1. What, if any, plans have been made towards a systematic and complete revitalization of our existing highway surfaces.
2. What plans, if any, have been made for widening and extending our highway system to care for the additional traffic needs.

3. What steps should be taken at this time to bring about proper planning, including the financing for the revitalization of our existing highway system and then the widening, extension and completion of a highway system that will be sufficient and adequate to care for our needs.

THE HONORABLE BOARD OF SUPERVISORS:

Your Ways and Means Committee, charged with the duty of presenting to this Board, a budget for the operation of the County for the fiscal year starting January 1, 1951 and ending December 31, 1951, respectfully submits the budget hereto attached, and by way of explanation thereof, states as follows:

The revised report of the Salaries Committee and report of the Appropriations Committee, copies of which were supplied to the Ways and Means Committee, have been duly considered and this committee presents the budget above mentioned, having in mind the principle that the appropriations and operating expenses should be in a sufficient amount to be consistent with the demands of each department and ample enough to make overdrafts unnecessary.

The amounts placed after the respective items in the budget have been arrived at by reference to the recom-

recommendations of the departments and the Board of Auditors and consideration has been given to the past experience as well as probable requirements for increase in service during the fiscal year the budget covers.

County Treasurer's Bond has been removed from Appropriations and placed in the Treasurer's budget. Probate maintenance, Probate-Juvenile Division and Juvenile Home budgets have been set up as one budget under Juvenile Functions.

On October 2, 1950, Mr. William McCarthy of Juvenile Court, appeared before this committee regarding the placing of twenty-six children in private boarding homes from the Juvenile Home. We increased the budget of Juvenile Functions approximately \$9000.00. This will provide these children with home-like surroundings, a much closer family relation and more direct parent control.

The Health Department budget has been substantially increased to provide better and more efficient operation of health work in the county under the new Health Board.

We have, by resolution, advised the County Clerk, commencing October 26, 1950, to charge \$2.00 for the issuance of a marriage license which will be the statutory fee of 50¢ plus \$1.50 to cover the estimated clerical cost involved. We have further advised the Clerk, as of the same date, to charge \$2.00 for each of the following:

1. Bench Warrant, 2. Writ of Attachment, 3. Orders to Show Cause.

Your adoption of this report will be a ratification of the action of the Ways and Means Committee mentioned in the paragraph immediately preceding this paragraph.

You are familiar with the report of the Oakland County Planning Commission, which report was presented at the last meeting of this Board. That report recommended continued contribution to the Regional Planning Commission and \$15,000.00 for County Planning. However, the Appropriations Committee did not feel that either request should be granted and consequently, no provision is made in the budget for such items. We believe that a study should be made of the overall planning problem in the metropolitan area and consideration should be given to the idea of procuring an expansion of the powers of the Huron Clinton Metropolitan Authority to take in this activity and recommend that our County Planning Commission contact the representatives from the other counties and the Authority with a view to bringing this about.

We have incorporated the sum of \$18,000.00 in the budget to enable the carrying out of the recommendations of the Equalization Committee made at the meeting of September 18, 1950 relative to assessments in the county and the Auditors, upon your adoption of this budget, will be authorized to disburse that sum under the direction of the Equalization Committee.

We recommend the continuance of the policy to have the Board of Auditors divide the budget of each department into four equal parts and, as soon as possible, after the close of each quarter, mail a copy of the financial status to all members of the Board of Supervisors and to each Department Head. The statement to show the amount of money allocated for a stated quarter, the amount expended and the balance or overdraft as the case may be, together with a suitable summary of a statement of revenues, statement of expenditures, including encumbrances compared with appropriations, statement of unappropriated resources and report of possible resources available for appropriation.

We recommend that each county official and each county employee be given two week's vacation during the calendar year of 1951 and receive their regular wage or salary during the vacation period.

We recommend that, in all cases where statutory holidays fall on, or by statute, are celebrated on Monday, that all county offices be closed from five o'clock P. M. the preceding Friday until 8:30 A. M. the following Tuesday. We recommend that in the institutions, such as hospitals etc. where part of the help must work on the days contemplated in the preceding sentence, that the Department Heads arrange an equivalent amount of time off as soon as possible after said holidays for such employees.

We recommend that the salaries herein provided for be in lieu of all fees, which fees belong to and be credited to the General Fund.

Albert Weber, Trustee, C. W. Seery, Chairman of the T. B. Committee, Dr. Mehas, Medical Director and George H. Williams, Manager, appeared before the Ways and Means Committee, recommending the following changes and improvements in working conditions and building changes: 1. Fire escapes and fire fighting equipment. 2. Recreational facilities. 3. Wardrobes for twenty-six rooms in the Nurses' Home. 4. Alteration of present storage space for Occupational Therapy. 5. Changes in Admission Building. 6. Change X-ray facilities. 7. Centralize present scattered dishwashing facilities.

Allowance has been made in the budget to take care of the above items, not to exceed \$30,000.00. These changes to be made under the supervision of Mr. Arthur, Maintenance Engineer, and the direction of the Board of Auditors, in cooperation with the management of the T. B. Sanatorium. Other necessary items requested will be made from regular building maintenance funds.

We further recommend that any Department Head who makes any unauthorized purchases shall be held strictly accountable therefor.

Mr. Chairman, I move the adoption of the budget and this report.

TO THE BOARD OF SUPERVISORS:

The County Road Committee respectfully submits the following report.

Miscellaneous Resolution #2566, concerning request of road system planning and revitalization:

(1) The County Road Commission is carrying on a systematic revitalization of existing highway surface according to the 1950 County Road Maintenance Program as outlined in its 37th Annual Report to the Board of Supervisors. The 1950 budget year will see a completion of 23-1/3 miles of road building which constitutes a complete revitalization program to the extent of allotted funds in the 1950 budget.

(2) The County Road Commission has given considerable time to future planning of widening and extension of the County Road System. However, the limitation of available funds prevents the Road Commission from executing its plans.

(3) Planning for widening, extension and completion of an adequate highway system is a proper function of the County Planning Commission. This Commission, by integrating the various phases of land use and traffic arteries with the requirements of the metropolitan area at large is the logical authority to develop highway planning in both phases, immediate and long range planning and development.

The County Road Committee therefore recommends to the Board of Supervisors to grant the request for the budgetary funds for the setting up and successful operation of a County Planning Commission office and its personnel. The Engineering Department of the County Road Commission is doing its full share of the detail work involved. Preliminary plans and studies by the Highway Commission are in progress. However, limitations both in staff and funds make it impossible for the County Road Commission to provide a comprehensive plan for an adequate road system. This should be done by the County Planning Commission which will have proper facilities to do so.

TO THE BOARD OF SUPERVISORS

Discussion by the Welfare Committee of the Public Administration Survey brought out the fact that, while the Committee finds itself in agreement with the general purpose of the report, it is evident that welfare as a function of county government was considered almost wholly from the administrative point of view and many important humanitarian objectives of a well-rounded welfare program were not given sufficient consideration. The study of the reporting agents was almost completely limited to the financial records available in the County Office Building and a careful estimate of the time spent in departmental field work and research in the actual offices and operating units of the Social Welfare Commission did not exceed more than a few hours.

In considering the direct criticisms of the present organization of the Department Of Social Welfare, we disagree with the statement that "the present Board functions without clearly defined authority and responsibility". The three man Board, sitting as a group, determines policy and discusses detail when necessary, with a clearly understood division of responsibility among the three. In the matter of details in each man's field, the others may understandably be not sufficiently informed to answer a direct question without reference to the record, but in the matter of overall policy, they are certainly in agreement and completely capable of carrying out the work of the department.

In connection then, the recommendation of the survey report that a single Welfare Director be substituted for the present three man board, does not meet with the approval of this Committee. Our observation of the experience in other counties as large as Oakland indicates that size and population limit the efficiency of a single director. In large counties, the three man Board has functioned to better advantage. The Committee feels that such a change would certainly increase the total administrative salaries paid in the Welfare Department since such a director of overall welfare would command a salary larger than those paid to the individual board members and he would need assistants as departmental heads whose salaries undoubtedly would approximate those of the present Welfare Board without a compensating increase in efficiency. It is our feeling that such a change would tend to make welfare a career instead of a service to humanity.

The Public Administration Survey, discussing the present use of the Infirmary, criticizes the Board of Supervisors for making no appropriation for the operation of the Infirmary. The Welfare Department has always been in favor of such a budget and the recommendation of the survey was wholeheartedly approved. You, as Supervisors, know that there is a specific appropriation in the budget and the Board of Auditors report that, so far, the Infirmary budget has met the needs.

Analyzing the statement made in the survey "that the distinction between County, Township and City poor is an unworkable one for the infirmary", it appears that the survey pays no attention to one of the valuable results of the present effort to charge certain basic costs back to the local units, i.e., the townships and the cities. When the cost of a patient in the Home Section of the Infirmary is charged back, even at an unrealistically rate to the political unit, it keeps the local authorities aware of the cost and the extent of the welfare of the local unit. It does seem that the local unit should constantly be alerted to and cognizant of the welfare problem. It can be argued that abolishing this distinction between "local" and "county" poor would save trouble and labor but it would certainly make the welfare problem more remote from local units and add to the cost.

In the details of management of hospitalization collections, some recommendations have been followed and necessary changes made in procedure. Statements are sent out and adequate agreements are signed. You may see a copy of such agreements attached to this report.

The recommendation of the survey that the Infirmary abolish its "Home" section and limit admission to persons qualifying under the hospitalization act is scarcely workable until other provision is made for the housing of such aged indigents. The "Home" section patients are a small proportion in any case and all of them are potential and, in many instances, imminent hospital cases. The housing of mental cases in the Infirmary is a transient problem due to overcrowding of the State Mental Institutions. Complete screening for both medical and mental is not always practical when an emergency patient seeks admission. This problem cannot be solved until the state does its duty by making adequate provision for such cases.

It is worthy of note that the Welfare Department, while not expressing approval or disapproval of the advantages or disadvantages of a central purchasing authority, has cooperated one hundred percent with the Board of Auditors in eliminating all question as to overlapping authority as evidenced by the resolution forwarded to the Auditors under date of June 27, 1950.

In concluding the study of the report of the Public Administration Survey, the Committee feels that the examination has been of benefit to its members and the department. The Welfare Board has already diligently started to use the good suggestions contained in the report. All suggestions and recommendations which may require Supervisors approval will be brought to your attention for your consideration.

With the cost of all types of welfare on the increase and with the cost of overall general welfare absorbing approximately 50% of the county budget, this Committee feels that the responsibility is a serious one and the foregoing report is presented after giving the items mentioned therein its solemn consideration and best judgment.

Ladies and Gentlemen:

Your Salaries Committee respectfully submits, for the consideration of this Board, the following report and recommends its adoption as the 1951 Schedule of Salaries for the officials and employees of the County whose salaries are fixed by this Board.

As stated in our previous report which was referred back to this committee on September 18, 1950, we have purposely omitted from the following resolution all particulars concerning the individual salaries because of the unwarranted details involved in making such entries in the Supervisors Journal. However, an abstract showing all such details will be made available to each member of this Board and copies will be filed in the permanent records of the County Clerk's office for use of the public.

#### OFFICIALS SALARIES

The terms of many officials, elected and appointed, will expire on December 31, 1950 and, after careful study and consideration, we are recommending salaries for the new terms which we deem proper, having in mind the duties and responsibilities to be assumed by such officials.

#### EMPLOYEES SALARIES

We recommend a blanket increase of approximately \$206.00 per annum. Any slight deviation from this figure is due to the fact that we have endeavored to make the total annual salaries divisible by twenty-six, which will facilitate the work of preparing the payrolls on a bi-weekly basis instead of the present semi-monthly basis.

In addition to the blanket increase, certain employees are entitled to an automatic increase within their classification range. To provide the necessary funds in the departmental salary budget, we have included all such increases although some employees will not be entitled to this additional increase until they have completed the required service of one year.

After careful study, we have recommended several changes in classifications as you will note in the abstract furnished you. These changes are justified due to organizational changes, specialized positions or in cases where the employee is required to assume additional responsibilities.
