#### SESSIONS OF THE OAKLAND COUNTY BOARD OF SUPERVISORS

Annual sessions of the Board of Supervisors are held on the Tuesday following the second Monday of April, on the fourth Monday of June and on the third Monday of September. A regular session may be held in January of each year by the adjournment of the September Session to a date certain in January.

Special meetings of the Board may be called by a request of at least one-third of all Supervisors, which request must be filed with the County Clerk at least fifteen days before the meeting.

RULE XVIII. (a) At the statutory meeting of this Board held on the

Tuesday following the second Monday in April of each year, the Board of Auditors shall submit to the Board of Supervisors a "Tentative Budget for allocation purposes" and the Board of Supervisors shall refer the same to a joint meeting of the Salaries, Appropriations and Ways and Means Committees, which Committees shall meet preceding the meeting of the Board of Supervisors held on the third Monday in April viz: the deadline for filing the final allocation budget with the County Tax Allocation Board.

- (b) There shall be a regular meeting of this Board at ten o'clock A.M. on the Friday preceding the third Monday in April at which time the joint committees referred to above shall consider their report to this Board with the recommendations on the adoption of the final allocation budget to be acted on the following Monday. The Chairman of the Ways and Means Committee shall act as Chairman of the joint Committees; however, if a majority of the personnel of any of the three committees does not concur with the joint committee report, the Chairman of that Committee shall present to the Board of Supervisors a minority "joint committee report" pointing out the reasons for nonconcurrence and the Board of Supervisors shall thereafter dispose of the matter according to its judgment.
- (c) There shall be a regular meeting of this Board at 10:00 A. M. on the last Tuesday of each October for the purpose of conducting a hearing on the report of the Committee On Local Taxes and authorizing the spread of the taxes covered by the report.

WHEREAS immediate steps should be taken to insure as effective a coordination program as is possible,

NOW THEREFORE, on behalf of the Appropriations Committee, I move that the sum of \$10,000.00 be appropriated
from the General Fund to be spent under the direction of the Ways and Means Committee to provide the personnel and
facilities necessary to cooperate in the Civilian Defense Program.

Gentlemen

WHEREAS the Governor, as a defense measure, proposes to have appointed, in each County, a Civilian Defense Director whose function it will be to integrate and coordinate civilian defense activities at the County level, and WHEREAS such Director, we are reliably informed, will be appointed by the Chief of Civilian Defense of the State of Michigan, Colonel Maitland, who in turn will be guided by the recommendation of the Board of Supervisors, and WHEREAS the Governor has requested from each County, prompt action pointing toward the immediate creation of the Civilian Defense Coordination Program,

NOW THEREFORE BE IT RESOLVED that this Board recommend that the salary for the Civilian Defense Director of Oakland County be set at \$5000.00 per year, said salary to be proportioned over any period less than a year during

which the office of the County Civilian Defense Director is in existence;

FURTHER that this Board recommend to Colonel Maitland, for favorable consideration, the name of Ray Harrington whose address is Pontiac, Michigan, as being possessed of the qualifications necessary to properly perform the function required of the office.

Ladies and Gentlemen:

Your Committee appointed to draft a resolution on the death of Fred Durfee beg leave to report as follows:

Mr. Durfee, a resident of Novi Township, was elected by his township as a member of this Board in 1920 and served for a term of years,

TO THE HONORABLE BOARD OF SUPERVISORS:

Your Township Expense Committee, for several years, has been aware of the fact that the Township Expense Reports were not prepared and approved by this Board in time to allow for the proper preparation of the Winter Tax Roll, which has brought about considerable confusion to the Supervisors and Assessing Officers. Because of this, your Township Expense Committee has given considerable study to the problem and would like to report as follows:

We find that Section 37 of the General Property Tax Law provides that the Board of Supervisors is to "examine all certificates, statements, papers and records submitted to it, showing the money to be raised in the several townships for school, highway, drain, township and other purposes. It shall hear and duly consider all objections made to raising such moneys by any taxpayer to be affected thereby. It shall direct that such of the several amounts of money proposed to be raised for township, school, highway, drain and all other purposes as shall be authorized by law, be spread upon the \*Assessment Roll of the proper townships, wards and cities." \*(M.S.A. 7.55).

We find that the Board is not concerned with the certification of city or village taxes and therefore, they should not be shown on the Certificate of Authorization by the Board.

We find that Section 2 of Chapter Ten of the Drain Law provides that the Drain Commissioner shall certify his Drain Rolls "to the County Clerk on or before the first day of the Annual Meeting of the Board of Supervisors", (M.S.A. 11.88). The Annual Meeting referred to falls on the third Monday in September.

We have prepared and will recommend the necessary procedure to cure the defects in our present system and coordinate this Board's activities with the pertinent law; however, such procedure involves an amendment to our Rules. Wherefore, Mr. Chairman, the Township Expense Committee gives notice that, at the next meeting of this Board, the following amendments to our rules will be offered:

- Abolish the Township Expense Committee.
   Create in lieu thereof a standing committee to be known as "The Committee On Local Taxes".
   Prescribe the functions of and time the actions of that committee.
- 4. Spell out in the form of regulations to be adopted by this Board the necessary acts to coordinate the Committee's functioning with other officials.
- 5. Provide for a regular meeting of this Board at 10:00 A. M. on the last Tuesday in October.

Pursuant to notice given at the last meeting of this Board, I move a section to be known as "Section 4" be added to Rule XII, said Section 4 to read as follows:

Section 4. The Committee on Local Taxes:

- 1. Shall prepare a form for Township and City Clerks to report to the County Clerk all taxes to be raised for Township, School, Highway and all other purposes as provided in Section 36 of the General Property Tax Law. (M.S.A. 7.54).
- 2. Shall receive and examine all certificates, statements, papers and records submitted to it showing the moneys to be raised in the several Townships and Cities for School, Highway, Drain, Township and all other purposes and if it shall appear to the Committee that any certificate, statement, paper or record is not properly certified or that the same is in anywise defective or that any proceeding to authorize the raising of any such moneys has not been had or is in anywise imperfect and such certificate, statement, paper, record or proceeding can then be corrected, supplied or had, such Board may authorize and require such defects or omissions of proceedings to be corrected, supplied or had. (M.S.A. 7.55)
- 3. Shall, after the second Monday in October, prepare a statement showing the taxes to be raised in each city or township for township, school, highway, drain and all other purposes including special assessment drain taxes, which statement shall also show the amount of county taxes apportioned to each city or township to be raised and shall mail the same to each Supervisor prior to the final meeting in October, giving him notice that at the final meeting in October, the Board of Supervisors will hear and duly consider all objections made to raising such moneys by any taxpayer to be affected thereby; and that if there are no objections, the Board will direct that such taxes shall be spread upon the Assessment Rolls of the proper townships and cities;

4. Shall present a recommendation in the form of a resolution to the Board of Supervisors at its final meeting during the month of October, recommending that such taxes be spread on the assessment rolls of the proper cities and townships;

5. Shall, as provided in Section 41 (M.S.A. 7.82) of the General Property Tax Law, supply a form for the Clerk of each city and incorporated village to report all taxes levied in their respective cities or villages, not included in the general (winter) tax levy, to the County Clerk.

6. Shall, after receiving such statements, cause to be prepared a statement as provided in Section 41 for the County Clerk, showing the aggregate valuation of all property as assessed in each assessing precinct within the County during the current year; also a detail of all taxes to be raised in the county for such year in all townships and cities; and shall submit the same to the County Clerk for filing with the Auditor General within thirty days after the close of the Annual Session of the Board of Supervisors in October.

Misc. 2595. By Mr. Goodspeed: MR. CHAIRMAN:

I offer the following resolution, the same to be a mandatory directive where this Board has the power to make the same, and a request for cooperation where indicated;

BE IT RESOLVED THAT:

1. The various school boards in Oakland County are hereby directed to file their reports of the amount of money to be raised by taxation with the Township or City Clerks by the first Monday in August as required by law.

2. The County Superintendent of Schools is hereby requested to assist the various School Boards to file the aforementioned reports correctly and by the proper time and to file with the committee on Local Taxes a report on compliance or non-compliance with the regulation by the school district. Such re-

port to be filed by the third Monday in August.

- 3. The County Tax Allocation Board is requested to send three color triplicate copies of a form for the school district to report tax levies to the various Township and City Clerks, to the various school districts, with the final tax allocation order; the original copy of the form to be filed with the Township or City Clerk; the second copy of the form to be filed with the County School Office and the third copy to be retained for their files.
- 4. The Drain Commissioner is hereby directed to submit his Certification of Drain Rolls to the County Clerk on or before the first day of the Annual Meeting of the Board of Supervisors, being the third Monday in September as is provided by law.
- 5. The Township Clerks and the City Clerks are directed to file their reports of Township and School Taxes to be spread with their Supervisor or County Clerk prior to October first as is required by law.
- 6. The Drain Commissioner, Supervisors and City Clerks take notice that no taxes can be ordered spread in the future unless such taxes are reported to the County Clerk prior to the second Monday in October.
- 7. The Ways and Means Committee is hereby directed to, each year, submit their budget report to this Board, ready for adoption, by not later than the first day of the annual meeting on the third Monday in September.
- 8. The Chairman of this Board is hereby authorized and directed to call such meeting or meetings of this Board as are necessary to bring about the approval of the budget and the incident appropriation by not later than the second Monday in October.
- 9. The Committee on Local Taxes is directed, in the future, to strictly carry out the policy declared in this resolution and to prepare and submit its recommendation for the approval of township, school, highway, drain or other taxes to be spread at a meeting to be held on the last Tuesday in October at 10:00 A. M. each year.
- 10. A meeting of this Board be held each year on the last Tuesday in October at 10:00 A. M. for the purpose of a hearing on local tax spreads as provided in Section 37 of the General Property Tax Law and directing that such taxes shall be spread upon the assessment rolls of the proper townships and cities.
- 11. The County Tax Allocation Board be requested to include a notice of the policy set forth in this resolution with its final Tax Allocation Report when it is sent out each year.

2. THIRD MONDAY IN SEPTEMBER: First meeting of October Session of the Board of Supervisors.

- 3. THIRD MONDAY IN SEPTEMBER: Drain Commissioner to file Certification of Drain Rolls and amounts to be spread at large on the County, Townships and Cities.
- 4. THIRD MONDAY IN SEPTEMBER: Ways and Means Committee to submit budget report ready for adoption to the Board of Supervisors.
- 5. OCTOBER FIRST: Township Clerks to file statement of local taxes authorized for school and township purposes with Supervisor.
- 6. OCTOBER FIRST: City Clerk to file Statement of School Taxes authorized to be spread with County Clerk.
- 7. SECOND MONDAY IN OCTOBER: Supervisor to file report of taxes authorized to be spread in Townships with County Clerk.

BE IT RESOLVED by the Oakland County Board of Supervisors, the governing body of said applicant, as follows:

- 1. That the construction of said public works is essential to and is to the best interests of the applicant and to the end that such public works may be provided as promptly as practicable it is desirable that action preliminary to the construction thereof be undertaken immediately;
- 2. That Earl L. Clark, Drain Commissioner for Oakland County, or his duly authorized representative be hereby authorized to file, in behalf of the applicant, an application (in form required by the United States and in conformity with said Act) for an advance to be made by the United States to the applicant to aid in defraying the planning cost preliminary to the construction of such public works, which shall consist generally of the construction of a drain or drains to relieve the present overloading of the Campbell Road Drain, the Royal Oak Drain, the Lawson Drain and the East Clawson Drain.

Gentlemen:

Your Animal Welfare Committee met with W. D. Aikens, County Dog Warden regarding a serious situation in trying to enforce the dog laws and render a satisfactory service with a limited staff of two full-time employees.

At present the Dog Warden's time is utilized in investigation of damage claims, inspecting kennels and checking on rabid dogs. His assistant's time is devoted to driving the county pick-up wagon and taking care of complaints. All other employees are on a fee basis, mostly from the sale of delinquent dog licenses.

To promote a more efficient service, we recommend that the Dog Warden be authorized to employ four full

To promote a more efficient service, we recommend that the Dog Warden be authorised to employ four full time Deputy Dog Wardens. These Wardens would be located in various districts throughout the County and could render prompt service in their respective districts.

We recommend, if your Honorable Body sees fit, to approve the employment of these men and that their

salaries be at the following rate:

Annual salary to be \$2000.00 per year from which they will pay their own automobile expense plus the following fees: \$1.00 per dog 3 months or older picked up by such Warden; \$1.00 for each litter of pups; \$1.00 for selling a delinquent dog tax after March 1 to December 10; 50¢ for selling a current dog license during the period March 1 to December 10. This covers sale of licenses to new owners or licenses for dogs becoming three months old after March 1.

We believe these additional full time deputies will be able to completely cover the county and will result in the sale of more licenses and render efficient service in the enforcement of the Dog Laws.

The Board of Auditors advises this committee that sufficient funds are on hand in the Dog Fund to finance our recommendation, if adopted.

Mr. Chairman, on behalf of the Animal Welfare Committee, I recommend that this report be adopted.

To pay one-half (\$1800.00) of the Inspector's salary, the other half deriving from fees.

4.
