Before a packed house of more than 500 invited guests attending his annual State of the County address, Oakland County Executive L. Brooks Patterson announced the county will begin using a new triennial budgeting process.

"We will be the first county in Michigan, and we believe the United States, to move to a triennial budget," Mr. Patterson said. "We will project line item detail out three fiscal years: the current fiscal year plus 2010 and 2011 as an example."

Currently, Oakland County is the only county in Michigan and one of the few governments in the U.S. that operates on the biennial budget.

By maintaining a two year rolling budget, Oakland County is able to stay in the black for the current fiscal year and the next, in this case 2009 and 2010.

"A three year budget will give us the benefits of what a two year budget has done – but obviously more," Mr. Patterson said. "It will give us more advanced notice; more long term planning; more opportunities to react before a crisis arises."

Mr. Patterson also took the time to praise the Fiscal Services Division for its 17-year exemplary record of earning the highest award for the Comprehensive Annual Financial Report from the Government Finance Officers of the United States and Canada.

He also credited Management and Budget Director Laurie Van Pelt, Deputy County Executive Bob Daddow and the Budget Task Force for their leadership in guiding Oakland County through turbulent economic waters and helping to maintain the county's prized AAA Bond Rating.

Mr. Patterson also acknowledged the many and significant contributions of county employees. He mentioned that since 1993, employees have donated more than a half million dollars to a weekly Casual Day Fund while also taking home dozens of local, state and national awards for their outstanding work.

One of the more exciting revelations in the nearly hour long speech was the fact Oakland County is in the process of organizing a Hollywood style film festival in 2010. Mr. Patterson said State Representative Gail Haines brought the idea to him about six months ago as a way to capitalize on the burgeoning film and entertainment industry that is sprouting roots in the state because of the advantageous tax policies designed to lure them here. Mr. Patterson also indicated that several local investors, lead by noted developer Alfred Taubman, is planning to build the state's largest film studio in Oakland County, creating almost 3,600 new jobs.

Mr. Patterson closed out his 15th annual address at the Michigan State University Management Conference Center in Troy by recognizing the contributions of former Michigan Congressman Joe Knollenberg and Oakland County Treasurer Pat Dohany who were both defeated in their bids for reelection in November.

### From Whence We Came...

### Witch's Hat Depot

In 1970 The Oakland County Sesqui-Centennial Executive Committee published the "Oakland County Book of History," encompassing the history of Oakland County from 1820-1970. This 623-page book will be used in future articles as a source and reference for the "From Whence We Came" articles. Readers are invited to share their own stories or add to the ones published.

From p. 346-347 (Lyon Township) - In 1871 the Pere Marquette Railway was constructed through South Lyon. The line ran from Detroit to Grand Rapids. Later the Grand Trunk Railroad also built lines through South Lyon. The Grand Trunk route connected to Jackson and Pontiac.

Later the Toledo and Ann Arbor Rail Company decided that it would be advantageous for it to connect with the routes of the Pere Marquette and Grand Trunk. The decision was effectuated by building a spur line from Ann Arbor to South Lyon. The connection didn't prove to be as profitable as estimated and the railroad removed the tracks one Sunday morning. The track removal was done on Sunday so that the local people would not be able to get an injunction to halt the work.

The coming of the railroads meant that the mail could be brought by train. Earlier it had come by horse and carriage from Ann Arbor. Rail service meant many advantages for the local farmers.


Now they could ship their produce to market and could obtain machinery the same way - a vast improvement over the horse and wagon methods they had been using.

Also, the Pere Marquette ran excursion trips to Grand Rapids and Detroit on Sundays. These one day trips were very popular with the people of South Lyon; they discussed their excursions all year long.

Many county residents and employees have seen the panorama of the Oakland cars shown at the top of the page and

on display at the Oakland County Courthouse. It has an interesting history.

The original photograph belonged to Mrs. Dorothy Foisy of Rochester Hills. The photograph documents the Oakland Motor Company's exhibit in the August 11, 1916 parade through Pontiac that celebrated Oakland County's centennial. Cars from every year of production (1908 to 1916) are featured in the lineup. In 1925 Oakland introduced a new, smaller car, called the Pontiac. By 1931 the Pontiac proved to be so popular that the name of the division was changed.

This original panoramic photograph, by H. George Studio in Pontiac, was brought to me coiled tightly in a cardboard shoe box. It showed some damage from years in storage as well as some damage from an earlier attempt at unrolling the photo paper image. The first thing to do was to get the image unrolled and reasonably flat to prepare it for scanning. I got out a home humidifier, allowing it to run directly under the photo, with the photo about two feet above it. After 3-4 days the photo was starting to unroll slightly. It was then placed on my ironing board with the humidifier underneath and I began to slowly let the photo unroll on its own, without any force applied. Each day I would refill the humidifier and further unroll the photo as the tension relaxed, being careful not to force it in any way. This process took about three weeks. In just less than one month I had coaxed the print to unroll enough for the next phase - scanning.

I scanned the photo in overlapping sections of about 10" each. The image had to be placed carefully to insure that there was some overlap in each scan. The entire image was nearly 6' long and had to be held stationary during the scans because of the overhang on each side of the scanner.

After scanning came the work of stitching the sections together. Each section was overlapped and blended with the previous section. After matching each 10" section by overlapping them there were a lot of small adjustments to make to exposure and contrast to get everything back into place on one image.

Due to the condition of the print and the anomalies of the original some blurring was unavoidable as the original panorama creator had not matched his photo plates perfectly, but the results were nevertheless rewarding. This panorama had not been seen in its entirety in decades, and now it is displayed for all to see!

When the troubled kids who are placed in Children's Village need some TLC, compassionate discipline or an attentive ear for their problems, Jeff Lewis is there to offer the help that is needed.

### Do You Have ESP?

You do if you're an employee of Oakland County! The program has yielded over \$5.5M in savings to the county in its 16 years of existence. All current county employees, with the exception of elected officials, administrators, managers, chiefs, and some supervisors, are eligible to participate in the Employee Suggestion Program, also known as ESP. The program was created by County Executive. Brooks Patterson and seeks to inspire employees to submit cost saving suggestions and more efficient business practices.

A committee of evaluators reviews an average of 110 suggestions each year. As suggestions are received, they are time stamped, logged into a database by the HR staff, and reviewed for eligibility by the ESP Coordinator. Some reasons that a suggestion would not be eligible include if it is a duplicate of a previously considered suggestion, the idea would require a change in Merit Rules or public law, or the idea is already under consideration. Suggestions submitted on the County's Cost Reduction Blog may also be submitted to the ESP Program if they meet ESP eligibility as stated above. They must be submitted separately on the ESP form. Eligible suggestions are assigned to an evaluator who consults with the appropriate department official(s) in order to conduct a complete investigation. The evaluator is not aware of who made the suggestion, nor is the suggestor aware of who is conducting the evaluation. The evaluator presents his or her findings to the ESP Committee which then votes whether or not to recommend the suggestion for implementation. The ESP Coordinator notifies the affected department(s) of the Committee's recommendation and monitors implementation, although the final decision rests with the implementing department.

Prizes for implemented suggestions are awarded annually at the County **Executive Holiday** Party. The awards, which are not paid for with taxpayer dollars, but by proceeds from the County Executive's Annual Golf Outing, are based on the amount of savings generated

# Q&A

- I have heard that the Blue Choice, Point of Service (POS) Medical Plan is being discontinued??
- Yes. Effective January 1, 2010, this plan will no longer be available. It is being discontinued by Blue Cross/Blue Shield.
- What will I need to do?
- If you have your current medical coverage through the Blue Choice, Point of Service Plan, you will need to select a new medical plan to be effective January 1, 2010 during the Natural Select open enrollment period which will take place in October.
- What plans will I have to choose from?
- You may choose from the Blue Preferred (PPO) Plan or the Comprehensive Major Medical (CMM) Plan. Some employees (hired prior to May 31, 2003) also have the choice of the Health Alliance Plan (HAP). Those who do not make a new selection during open enrollment will be placed into the Comprehensive Major Medical (CMM) plan by default.
- What should I do between now and open enrollment?
- We recommend that you talk with your doctor about the alternative medical plans you will have available so during the open enrollment period you will know which plan will best suit your medical needs going forward. Please refer to your Natural Select workbook from last fall for details on the medical plans. You may also find information on the plans and bi-weekly contribution amounts at www.ocbenefits.com

## PERSON TO PERSON L. Brooks Patterson

The budget challenges confronting Oakland County over the next few years will be severe. Much of what we're facing is out of our control – a 15-month long national recession; auto sales at the lowest level in over 25 years; a statewide unemployment rate that tops the nation at 10.6%; escalating home foreclosures and property values rapidly on the decline.

But that doesn't mean we're sitting idly by doing nothing just hoping for things to get better. Our twoyear rolling budget and five-year economic forecast gives us a longer range view than most on where our fiscal train is heading which gives us the advantage of seeing and dealing with potential problems earlier.



This approach has enabled us to develop balanced budgets for 2009 and 2010. Now we're pushing the envelope even further. As I announced in my February 3rd State of the County address, we will soon be using a three-year budget process, something no other county in Michigan or America for that matter is doing.

It will give us all the benefits of a two-year budget but more – more advanced notice; more long term planning; and more opportunities to react before a crisis emerges.

A three-year budget is a bold move because it's really tough to develop reliable figures that far in advance. But I have total confidence that my award winning Management and Budget team can handle this challenge as they have done so many others in the past.

Over the past decade when signs of a recession started appearing on the horizon, we were very aggressive in adjusting the budget to make sure spending did not exceed revenues.

We took numerous proactive steps like implementing technological enhancements including e-Government, an asset management system and GIS; restructuring and downsizing which has resulted in \$37.6 million worth of savings through privatizations since 1993 and retirement incentive offers in 2002 and 2008 which lead to 379 retirements and 343 deleted positions. We also instituted a hiring freeze and made changes in fringe benefits to cope with declining property tax revenues which account for 59% of our General Fund / General Purpose budget.

Our current strategy is to work on the projected shortfall for 2012 – three years out – to accelerate some of the savings by taking early action. In other words, our goal is to cut the budget by \$10 million in each of the next three years so that by 2012 we will have trimmed some \$30 million from the General Fund, making our future budget tasks all that more manageable going forward.

Each of the countywide elected officials – Sheriff, Prosecutor, Clerk, Drain Commissioner, Treasurer, Board of Commissioners and Circuit & Probate Courts – has been given a budget task equal to their particular portion of the budget shortfall. They have all promised to do their part to keep Oakland County heading in the right direction.

No doubt about it, these are extremely tough times in which we live. But I am confident Oakland County will emerge from this economic crisis better and stronger than ever before.

### Administrative Enhancements to Prescription Drug Plan

The Department of Human Resources is pleased to announce that with the addition of Navitus Health Solutions as your prescription drug provider in April of 2008, several administrative enhancements have become available. In this article we will just touch on those that are taking place. Please note that all of these enhancements are effective beginning July 1, 2009.

### 90 Days at Retail

You will be able to obtain a 90 day supply of medication at participating local retail pharmacies, with one co-payment. This is the same benefit you now have through the mail order provider, WellDyneRx. You may of course continue to utilize WellDyneRx for your 90 day prescriptions if you wish. The choice will be yours.

### **Tablet Splitting**

You will be able (though not required) to split certain approved medications in half and save half the co-payment. Rather than receiving a quantity of 30 tablets for a 30 day supply of a drug with a 10mg strength and pay a \$10 co-payment, you could receive a quantity of 15 tablets for a 30 day supply of a drug with a 20mg strength, cut them in half (which would give you 30 doses) and pay only a \$5 co-payment.

### **Generic Copay Waiver Program**

To encourage the use of generic medication, if your doctor writes a prescription for one of the generic drugs covered under the generic co-pay waiver program your first 30 supply of the drug will have a \$0 (Zero) co-payment.

### **Formulary Transition**

In order to complete our transition to the Navitus formulary, Navitus will be taking steps to phase out the Blue Cross/Blue Shield formulary, which has continued to be used since the April 2008 move to Navitus. For the vast majority of employees, this transition will be completely transparent. For some, it will result in co-payments changing on prescription drugs you already receive (for those with the three tier drug plan). This same process occurred periodically under the Blue Cross/Blue Shield formulary as drugs moved from one payment tier to another. Lastly, the Navitus formulary includes Prior Authorization, Step Therapy and Quantity Limits provisions for a limited number of drugs.

### **Over the Counter Drugs**

As part of the transition to the Navitus formulary, certain over the counter drugs will be covered with a doctor's prescription.

### In Summary

It's important to note that the co-payments of \$5 for tier 1 drugs, \$10 for tier 2 drugs and \$25 for tier 3 drugs are not changing. We know you probably have questions so watch for more information being sent out over the next few weeks.

### New Faces in County Government for 2009

Oakland County's new prosecutor, Jessica Cooper, has worn various judicial robes during her distinguished 28 year career, starting at the District Court level and rising to the Michigan Court of Appeals.

As a young attorney in 1978, Ms. Cooper ran for 46th District Court and in an upset victory beat the incumbent. In the process, she became the first female judge in Southfield and one of only a handful in Oakland County.

In 1986, Ms. Cooper was elected to the 6th Circuit Court in Oakland County where she served until 2000.

During her tenure on the bench in Oakland County, Ms. Cooper presided over the high profile murder trial of Jack Kevorkian who she sentenced to prison for 10 to 25 years after he was convicted by a jury of second degree murder.

Oakland County has two new judges sitting on the 6th Circuit Court bench succeeding retiring judges Fred Mester and Steven Andrews. Probate Judge Barry Grant also retired and was succeeded by Judge Daniel A. O'Brien.


Lisa Gorcyca who was the top vote-getter in the November election is a former assistant prosecutor worked as chief of the prosecutor's office of domestic violence and elder abuse. She is married to former Oakland County Prosecutor David Gorcyca. Judge Gorcyca will preside over the court's Civil / Criminal Division cases.

The Honorable Eileen Brennan also donned her judicial black robe during investiture ceremonies at the Board of Commissioners auditorium in January. Judge Brennan, who comes to Circuit Court from the 44th District Court in Royal Oak was assigned to the Family Division.

On Thursday, January 8th, members of the Oakland County Board of Commissioners were sworn into office. In addition to the twenty returning members of the commission five new members were sworn in.

Kim Capello, Republican, represents Novi, Novi Township and Northville. Janet Jackson, Democrat, represents Lathrup, Berkley and a portion of Southfield. Gary McGillivray, Democrat, represents Madison Heights with portions of Royal Oak and Troy. Steve Schwartz, Democrat, represents Farmington, Farmington Hills. ### Behind The Scenes



Emergency Response & Preparedness (ERP)

#### **Overview**

Oakland County Emergency Response & Preparedness (ERP) is responsible for the day to day activities for emergency management. Many of the things we do are behind the scenes – planning, grant writing, disaster exercises, and developing brochures for the public to be prepared for any natural or man made disaster situation that can occur in Oakland County.

It gets real busy when emergencies occur – the 2003 black out, chemical releases (Oakland County has over 400 facilities with hazardous substances, not including what is transported through the county), train derailments, tornado touchdowns, etc. We house Oakland County's Emergency Operations Center (EOC) where over 28 county departments and private agencies, such as the Salvation Army, assemble to provide a coordinated response and recovery effort. We also activate the EOC for special events such as the PGA Championship and the Woodward Dream Cruise.

### Spotlight

Due to the severe storms that blew through Oakland County last year, effective immediately the outdoor sirens will be activated,



not just for tornadoes, but for severe thunderstorms with damaging winds at/near/greater than 70 mph.

Be prepared for the upcoming storm season. County employees can print materials available on our website at www.oakgov. com/erp. ERP staff is the voice behind the severe weather box that goes off on Thursdays and during severe weather.

The biggest problem we face today locally and nationally is getting the public to take more responsibility for their own

preparedness in case of a disaster. So as a county employee you need to make a family disaster plan and create a 72 hour disaster kit that includes food, water, flashlight, radio, medicine, etc. Be prepared, be aware of your environment and listen to local media daily for weather reports. You can also take one of our courses, such as CPR and AED.

### **New Stuff**

ERP and FM&O developed the Facility Emergency Preparedness and Response Plan currently



being rolled out which outlines procedures to protect county employees and visitors during a situation that affects buildings on the county campus and/or county offices off campus.
