The Fifth Annual High School Band Clinic of the University of Michigan will take place during the three weeks beginning July 7. More than a hundred high school musicians, specially recommended by their supervisors and principals, are in attendance each year.

Professor William D. Revelli, Director of the University of Michigan Band is in general charge. Associated with him, and providing intensive instruction for the boys and girls will be the following: Erik W. Leidzen, New York City; Cleo G. Fox, Kalamazoo, Michigan; Dale C. Harris, Pontiac, Michigan; Clifford P. Lilly, Chicago, Illinois; and Arthur Schwuchow, Aberdeen, South Dakota.

Supplementary to the training in ensemble and music generally, the young people have splendid opportunities of absorbing much of an intellectual nature from their association in the University environment—concerts, lectures, social and athletic activities, as well as health supervision is provided. These features including board and room are all covered by a single blanket fee. Candidates for admission should make application at once to Professor Revelli, since the list will be closed at an early date.

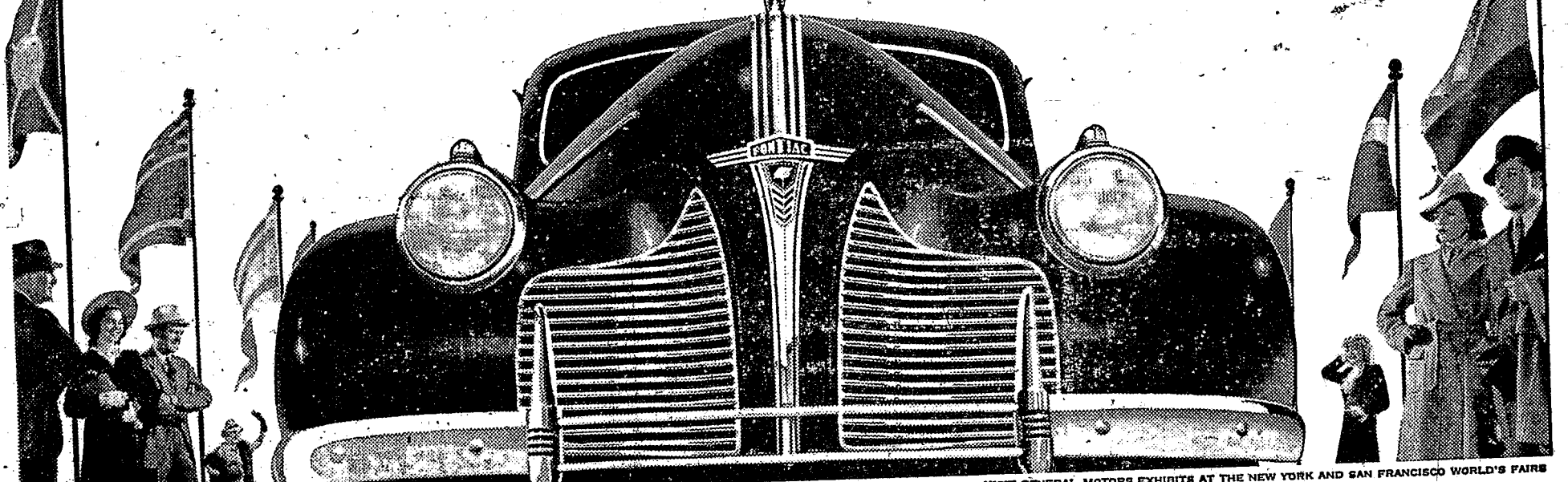
