

Oakland County, home to a mix of urban and rural communities, with its 30 downtown areas and many scenic natural settings, provides a high quality of life for any lifestyle. Countless outdoor recreation opportunities are available including: 3 ski areas, 27 public fishing sites, over 60 public golf courses, more than 1468 lakes and approximately 89,000 acres of public recreation land. Significant entertainment and sports venues include DTE and Meadowbrook outdoor theaters, the Palace of Auburn Hills — home to the Detroit Pistons, Cranbrook Institutions and the Detroit Zoological Park. Oakland County also ranks as the fourth wealthiest county in the nation among counties with populations of more than one million people. Like all of Michigan, the County enjoys the variety of four distinct seasons with an average temperature of 51 degrees Fahrenheit, a high of 77 degrees in July and a low of 23 in January.





Educational Attainment of People Over 25 Years of Age



Population by Age







Educational Attainment of People Over 25 Years of Age



Population by Age





Educational Attainment of People Over 25 Years of Age













Population by Age







Educational Attainment of People Over 25 Years of Age





One of Keego Harbor's first residents settled in the area in 1864. The Detroit Urban Railway built its trolley line in 1890's. It went out from West Huron Street in Pontiac to the present day Telegraph Road, then south and around the end of Sylvan Lake to Orchard Lake. 

Educational Attainment of People Over 25 Years of Age







Population by Age







Population by Age





Population by Age




The City of Rochester, dating from the 1850s, is a vibrant Mainstreet community of 3.8 square miles. It became a village in 1869 and was incorporated as a city in 1967. Most of the original buildings comprising downtown are still in use, some registered as Michigan Historic Sites. Parks, walking trails and tree-lined streets in neighborhoods with modest homes give the city much of its charm. Paint Creek and the Clinton River flow though the city and the municipal park provides a people focus for the City of Rochester. The city is governed by an elected, seven-member city council and headed by an appointed city manager. Rochester provides full city services including police, fire and water/sewer services. The Leader Dogs for the Blind staff can frequently be seen on the streets with dogs in training. September attracts thousands for the Art & Apples Festival. In December, shoppers descend on downtown for the annual Lagniappe night, where shoppers receive a small gift as a "thank you" for their patronage of local shops.



The Charter Township of Royal Oak is an incorporated residential community located in two separate areas in southeastern Oakland County. In 1826 Daniel Burrows donated land for use as a cemetery. The first burial was the infant daughter or Laura Swift Chase and David Chase, who later served as township supervisor and a delegate to the "Convention of Assent" for Michigan statehood. In 1857 it was taken over by the Royal Oak Township Board of Health. The cemetery contains the remains of veterans of all U.S. wars from the American Revolution through the Vietnam War as well as pioneers and prominent citizens. A boulder in Section J gives the names of township residents who died in the Civil War and World War I. Integrated since the beginning, this cemetery has been owned and maintained by the city of Royal Oak since 1921.





Educational Attainment of People Over 25 Years of Age











Educational Attainment of People Over 25 Years of Age








