Weiss noted that she would be leaving, following her report to the Board, to attend the Livingston County Literacy Council's recognition event.

Submitted application for the Michigan Department of Education-Adult Literacy Grant for \$20,000. Letters of support included ones from Ferndale Adult Education and Jose.

An application has also been submitted for the \$10,000 Innovations Program Award through The Ford Foundation and the John F. Kennedy School of Government at Harvard University.

Helen Dickinson has joined the staff as coordinator of the Oakland Reading Partners program, funded by the Oakland Law Foundation.

8. NEW BUSINESS - Literacy Contract (moved forward on agenda).

Jose reported that only minor changes have been made to the Literacy Project contract. These include replacing Oakland Schools with OCC, the payment amounts, and that the budget will be developed by the Council's Advisory Board.

A. WAYNE-OAKLAND LIBRARY FEDERATION - Hill.

Hill reported that progress has been made on the long-range plan and the Long-Range Planning Subcommittee is working to put together a plan that will be agreeable to all the member libraries.

Hill noted that the Geac system's uptime for all modems during December was 100%.

B. LIBRARY FOR THE BLIND AND PHYSICALLY HANDICAPPED (LBPH) - Hund.

Hund distributed copies of two flyers. The first flyer announced a family story hour in American sign language on January 25. The second flyer lists special services available through the LBPH and was funded by a LSCA grant.

Another \$5,000 has been donated by a patron who, since December, 1989, has donated \$12,000 in total to the LBPH.

Hund read a letter from the son of a patron who expressed his appreciation for the library's services.

Hund voiced her concerns regarding the move of the LBPH from its present location to the new site, particularly in regards to the loss of the materials they share with Farmington.

Hund volunteered to assist in developing a collection development policy for the Reference Library, incorporating the needs of the LBPH.

Hund informed the Board that she had received a copy of the Library of Michigan's comparative annual report on the regionals and subregionals of Michigan.
