Enter the amount of any Re-assessment with Red Ink, in the column of The attention of assessing officers is especially called to sections 15 to 27 of the Tax Law of 1882; they should be carefully studied and the directions therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1884.

Personal Estate must be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in numerical order, beginning taxes to which it belongs, above the tax for the year for which this Roll is used, and in the column for "Remarks" state opposite each parcel for what year the re-assessment was made.
