Personal Estate must be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in numerical order, beginning with taxes to which it belongs, above the tax for the year for which this roll is used, and in the column for "Remarks" state opposite each parcel for what year the re-assessment was made.
