"No more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be joined in one valuation or tax, unless owned and OCCUPIED as one parcel with one use, and if the name of the owner is not known, they should be assessed as 'foreign unknown.' Before the amount of any re-assessment with 2nd List, in the column The attention of assessing officers is especially called to sections 15 to 27 of the Tax Law of 1890; they should be carefully studied and the directions therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1890.

Non-resident lands should be entered in numerical order, beginning with section one, and if the name of the owner is not known, they should be assessed as 'foreign unknown.' Before the amount of any re-assessment with 2nd List, in the column of taxes to which it belongs, show the tax for the year for which this Roll is used, and in the column for 'Remarks' state opposite each parcel for what year the re-assessment was made.
