

PONTIAC BILL POSTER

STATE OF MICHIGAN, county of Oakland, ss.—At a session of the Probate Court for the county of Oakland, holden at the Probate office, in the city of Pontiac, on the 10th day of February, in the year one thousand eight hundred and eighty-five.

Present, Thomas L. Patterson, Judge of Probate.

In the matter of the estate of Emanuel Newman, deceased.

On reading and filing the petition, duly verified, of David Crawford, praying among other things that a specific performance of land contract may be decreed, and that by such decree William Williamson, the administrator of the estate of said deceased, or his successor or successors, may be authorized and directed to make and execute a conveyance of the real estate described in such contract, and that such other proceedings may be had in the premises as may be required by the statutes in such case made and provided.

Thereupon it is ordered, that the 12th day of March, 1885, at ten o'clock in the forenoon, be assigned for the hearing of said petition and that the heirs at law of said deceased, and all other persons interested in said estate, are required to appear at a session of said Court, then to be holden at the Probate Office, in the city of Pontiac, and show cause, if any there be, why the prayer of the petitioners should not be granted; and it is further ordered, that said petitioners give notice to the persons interested in said estate, of the pendency of said petition, and the hearing thereof, by causing a copy of this order to be published in the Pontiac Bill Poster, a newspaper printed and circulating in said county of Oakland, four successive weeks.
