Two descriptions must not be joined in one valuation or tax, unless owned and occupied as one parcel with section one, and if the name of the owner is not known, they should be assessed as "owner unknown." Enter the amount of any Re-assessment with Real Estate, in the column of the amount of the assessment. The attention of assessing officers is especially called to sections 15 to 27 of the Tax Law of 1882; they should be carefully studied and the directions therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1884.

NOTE: Personal Estate must be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in numerical order, beginning with taxes to which it belongs, above the tax for the year for which this Roll is used, and in the column for "Remarks" state opposite each parcel for what year the re-assessment was made. 1882-1884
