

Assessment Roll for the Township of Branford

in the County of Delaware for the Year 1890

No more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be joined in one valuation or tax, unless owned and occupied as one parcel with section one, and if the name of the owner is not known, they should be assessed as "owner unknown." Enter the amount of any abatement with the tax in the column. The attention of assessing officers is especially called to sections 15 to 37 of the Tax Law of 1889; they should be carefully studied and the directions therein contained should be strictly followed.

Personal Estate must be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in numerical order, beginning of lands to which it belongs, above the tax for the year for which the Roll is used, and in the column for "Remarks" state opposite each parcel for what year the re-assessment was made.
