

Assessment Roll for the Township of Ann Arbor

in the County of Oakland for the Year 1897

When more than one tract or parcel is valued or taxed on the same list, two descriptions must not be joined in one valuation or tax, unless owned and occupied as one parcel with section one, and if the names of the owners is not known, they should be assumed as "owner unknown." Enter the amount of any assessment with the job in the column. The attention of assessing officers is especially called to sections 12 to 17 of the Tax Law of 1891 they should be carefully studied and the directions therein contained should be strictly followed. - ATTORNEY GENERAL'S OFFICE, 1890

Personal Estate must be valued and taxes entered on a different list, as well as column, from Real Estate. Non-resident lands should be entered in unincorporated cities, towns or places to which it belongs, where the tax for the year for which this bill is used, and in the column for "Personal" state opposite each parcel for what year the re-assessment was made.
