

Assessment Roll for the Township of Ann

in the County of Oakland for the Year 1897

If more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be added to one valuation or tax, unless owned and occupied as one parcel with a common use, and if the name of the owner is not known, they should be assessed as "owner unknown." Enter the amount of any re-assessment with full date, in the column on the right. The attention of assessing officers is especially called to sections 13 to 16 of the Tax Law of 1880 (they should be carefully studied and the directions therein contained should be strictly followed)—LUCIUS GERRARD'S OFFICE, 1897

Personal Estate must be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in unincorporated cities, towns or places to which it belongs, show the tax for the year for which this Roll is used, and in the column for "Remarks" state opposite each parcel for what year the re-assessment was made to strictly followed.—LUCIUS GERRARD'S OFFICE, 1897
