

ASSESSMENT ROLL FOR THE TOWNSHIP OF *Independence*

IN THE COUNTY OF *Ratliff* FOR THE YEAR 1889

No more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be joined in one valuation or tax, unless owned and occupied by the same person, and if the name of the owner is not known, they should be assessed as "owner unknown." Enter the amount of any *Ex-emption* with *End* the re-assessment was made. The attention of assessing officers is especially called to sections 18 to 27 of the Tax Law of 1888; they should be carefully studied and the directions therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1888.

Personal Estate must be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in numerical order, in the column of taxes to which it belongs, above the tax for the year for which (1888) is used, and in the column for "Remarks" state opposite each parcel, for what year therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1888.
