

ASSESSMENT ROLL FOR THE TOWNSHIP OF Sandwich

IN THE COUNTY OF Calhoun FOR THE YEAR 1889

No more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be joined in one valuation or tax, unless owned and occupied by the same person, and if the name of the owner is not known, they should be assessed as "owner unknown". Enter the amount of any Re-assessment with foot the reassessment was made. The attention of assessing officers is especially called to sections 13 to 17 of the Tax Law of 1888; they should be carefully studied and the directions therein contained should be strictly followed—AUDITOR GENERAL'S OFFICE, 1888.
