No more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be joined in one valuation or tax. Real estate owned and occupied as one parcel. Personal Estate must be assessed as "owner unknown." Enter the amount of any assessment with red ink in the column of taxes to be paid for the year for which this Roll is made, and in the compact the word "Overdue" and on the same line as the name of the mortgagee (if the amount is accumulated), the word "Mortgagee." In column 1 on the same line as the name of the owner (or occupants, if the same line as the name of the mortgagee enter the value of interest represented by mortgage, deed of trust or other obligation. The attention of assessing officers is especially called to sections 25 to 27 of the

be valued and taxes entered on a different line, as well as column, from Real Estate. Non-resident lands should be entered in assessment order, beginning with section one, and if the name of the owner is not known, column for "Remarks" state opposite each parcel for what year the re-assessment was made. In column 2 enter on the same line as the name of the owner the word "Overdue" on the same line as the name of the owner to the occupant) enter the value of property of the owner, i.e. the true and just value of the land less interest represented by mortgage, deed of trust or other obligation, if any.
