

ASSESSMENT ROLL FOR THE TOWNSHIP OF *Endicottville*

IN THE COUNTY OF *Oakland* FOR THE YEAR 188*9*

No more than one tract or parcel must be valued or taxed on the same line. Two descriptions must not be joined in one valuation or tax, unless owned and occupied by the same person, and if the name of the owner is not known, they should be assessed as "owner unknown." Enter the amount of any *Re-assessment with kind* for re-assessment was made. The attention of assessing officers is especially called to sections 19 to 27 of the Tax Law of 1885; they should be carefully studied and the directions therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1886.

As one parcel, *Personal Estate* must be valued and taxes entered on a different line, as well as column, from *Real Estate*. Non-resident lands should be entered in numbered order, beginning with section one, and if the name of the owner is not known, they should be assessed as "owner unknown." Enter the amount of any *Re-assessment with kind* for re-assessment was made. The attention of assessing officers is especially called to sections 19 to 27 of the Tax Law of 1885; they should be carefully studied and the directions therein contained should be strictly followed.—AUDITOR GENERAL'S OFFICE, 1886.
