# Soup's a Whole Meal When Made Like This

Mrs. Louis Mallette "Whenever you make soup remember that the longer you cook it the better it is," Mrs. Louis Mallette's mother told her when she gave her these two favorite family recipes.

Her daughter added another line, "Every time you reheat it, the better it tastes." Mrs. Mallette recommend at least two hours cooking time. She usually counts on a whole morning to do it justice.

When the Mallette's have soup, they make a meal of it. A tossed salad goes nicely with the bean soup, Mrs. Mallette savs. She likes a cottage cheese salad with the vegetable

individual tastes, Mrs. Mallette NAVY BEAN SOUP 1 lb. pkg. navy beans 1½-2 lbs. short ribs or ham an

ham bone 2 qts. water 2 small onions, diced 2 stalks celery, diced Soak beans ovenight. To prepare soup, cook meat in

36 pkg, frozen green beans 1/2 pkg. frozen peas 1/4 cup rice 11/2 tsp. salt pepper Cook meat in water at low heat until it is tender and falls off the bone.

Remove meat from broth. Trin off fat and cube meat. Return meat (minus fat) to broth. Add tomatoes, onlons, celery (including leaves), carrots and cabbage.

### CITY OF NORTHVILLE

RECIPROCAL HEATING ORD. NO. 150

An Ordinance to regulate the design, construction, installation, maintenance and use of oll burning equipment for use in connection with all types of space heating equipment, hot water supply and steam generating equipment and appliances and appurtenances thereof; and all gas fired space heating equipment and appliances and appurtances thereof, in the City of Northville, Michigan; to provide for a board of examiners and its powers and duties; to provide for the licensing of contractors; to provide a reciprocal arrangement for the recognition of examinations and licenses issued by other municipalities of the State of Michigan, voluntarily cooperating in the enforcement of this ordinance; to provide a penalty for the violation of the terms thereof and repealing all former ordinances and amendments thereto conflicting therewith.

THE CITY OF NORTHVILLE ORDAINS:

Section 1. That a certain document, copies which are on file in the office of the City Clerk of the City of Northville, being marked and designated as City of Detroit Official Gas and Oil Burner Code as Amended Through July 3, 1958, be and the same is hereby adopted by reference, including all references therein printed except those sections and appendices herein amended or added, and this document together with the provisions of this Ordinance shall be known as the official heating code of the City of Northville.

Section 2. Whenever in said reference ordinance, a municipality is mentioned, said municipality shall be construed to mean the City of Northville, Michigan. Whenever in said reference ordinance the word "Commissioner" is used it shall be construed to mean the City of Northville heating inspector. Whenever in said reference ordinance a Board of Appeals is mentioned it shall be construed to mean the City of Northville Building and Zoning. Whenever in said reference ordinance the Board of Examiners is mentioned, it shall be construed as the City of Livonia Board of Examiners which shall serve as the Board of Examiners for the City of Northville.

Section 3. Section 4.6: The first paragraph of this section shall be amended as follows: The fees for examinations, licenses, registrations, permits and inspections, and appeals shall be determined by the City Council, by resolution, subject to the following minimum and maximum amounts:

Section 4.7. Collection of Fees. The City Clerk shall be substituted for the Bureau of Licenses and Permits as collection agent.
