Although Oakland county voters, ncluding those from Novi and Wi om, turned down both proposition dealing with the county building project by overwhelming margins Novi Township Supervisor Fraze Staman predicts that the additions to the new court house will be built

Staman, a member of the county building committee, indicated Tues-day night while waiting for the returns that the negative vote would definitely curtail the building proj ects for a few years, but he said Oakland county will still get the additions by other financial means, Steps to find some other mean to get the money may be taken today by the board of supervisors Staman said. "Paying for the additions with

money raised from some other source is going to cost the taxpayers more money in the long run," the Novi supervisor said. "If the people would have approved these propositions the addition would hav been paid for by the time it was completed. There would have been no interest, no bonds," Oakland county residents turned down the proposition authorizing the county to levy a special tax of onehalf mill by a vote of 35,374 to 19.983. The county tax limitation proposition on the same matter far ed a little better, 35,908 to 21,747. Novi voters voted against the

sinking fund, 274-203 and against the tax limitation, 281-248. Wixom voters turned down the first 110-70, and the second, 98-62.
