

Today in our community, and many others throughout the nation, youngsters return to their desks to resume the education process that had been interrupted by summe vacation. How much their minds absorb between now and nex

June depends almost entirely upon their individual teach-And when one stops to consider this, it leaves but

one conclusion: The teacher is a most important person. That's exactly what John H. Fischer, dean and president-elect of the Teachers College of Columbia University, had to say in an editorial he wrote recently for the National Education Association Journal. It was entitled "Why Teach?"

He points out that it is the teacher to whom everyone turns to find out whatever is wrong with youth or the world. The same teacher is the butt of poor jokes, object of endless criticism, and scapegoat for many of society's comings, the author notes.

There is a new appreciation of the teacher, Fischer points out, based upon the realization that "the central element in all our power, in all our plans for using power, is the educated man."

He believes that there is a new desire among our best young men and women to teach because they want most of all to spend their lives in worthy causes. And the attention and recognition teachers are now receiving are more responsible for this desire than improved salaries and working onditions - although these realistic elements cannot be

The Columbia University Dean says: 'The change is not, however, without its unpleasant

side, for while the glare of the spotlight may lend the teacher something of a halo, it also reveals his flaws with a minimum of mercy. No longer can teaching be a sinecure for those who want a job with long vacations or a monthly check to tide them over until something better comes along. Nor is there room in modern schools for teachers who lack the capacity for self-criticism or the will-

ingness to work at a task that is endless and ever-changing. Why teach? Whether the question is asked by a college student on the threshold of a career or by a forty-year veteran with chalk dust in his blood, the answer can be given in many ways. Twenty years ago Lyman Bryson put t gracefully and well when he called the teacher 'the friend who makes men free

"Running through all the answers, if they are honest nd wise, will be a thread of commitment — a note of with To find success or satisfaction in his work, a teacher must begin and end with frith - in the worth of all men and especially in his students; in all learning and particuarly in what he reaches. But most of all, the teacher must believe in himself and in the value of what he is attemptng to accomplish."

It seems most appropriate that we take time now, as classes resume, to recognize the efforts of our teachers and remind them, too, in case they face return (or beginning) to duty with less than full heart, that they are among our ommunity's "most important people". Main street in Northville may soon get a new look ---one designed to entice more shoppers by means of easier parking and improved traffic flow.

The idea was conceived by Earl Wineman, new president of the Retail Merchants association and owner of E-Jay Lumber Mart. And it follows in principle very closely the long-range master plan currently being prepared by Northville's planning commission

So when he unveiled a drawing of the idea to planners recently, it met with general acceptance and a proposal to the commission planning consultant to study the plan and suggest any needed refinements. Then planners vill ask the city council to approve it on a trial basis.

Winemon proposes to make Main street traffic between Hutton and Center one-way - west only. Angle parking on both sides of Main street would then be permitted. He also proposes to remove street park-

ing meters. Traffic would be directed eastward through the "parking alley" between South Center street and the Presbyterian

church. Thus access to Main street in the single block "oneway" area would be gained either off Hutton, the parking alley or via West Main street. The planners thought the idea was "not inconsistent

with their own master plan (soon to be announced after many months of study) and could serve as a "first step" Some concern was expressed at the reversal of the 'parking alley" traffic because of the difficult entrance from South Center street — and it's possible this might be revised

There are, too, sharp differences of opinion concerning removal of parking meters from the streets. The city manager has recently proposed removal of all

meters from parking lots, including the "parking alley", He would prefer to replace the present automatic met-

ers on the streets with easier-to-maintain manual meters d then embark upon a program of strict enforcement. His theory is that multi-hour or all day parkers could e permitted to use lots, while the shopper in a hurry could use the street parking. And meters properly enforced and in working order discourage long use of parking spaces thereby providing available parking at all times for the quick-stop shopper-

Right on the heels of these efforts to improve shopping conditions locally has come the proposal by the city ouncil to bay the Main street lot across from the theatrefor municipal parking.

This lot already receives heavy parking, although it is privately owned. And we agree with the council that it is imperative that it should be maintained, at least until an opportunity for desirable commercial use is found.

The encouraging point for all businessmen to note is that something is being done; Wineman's enthusiastic approach to introduce a new idea and the efforts by city officials should be bailed by all tocal businessmen.

Their cooperation, ideas and, possibly financial as sistance, will be needed. With increasing competition from shopping covers it's imperative that we all pull an oar in the same direction.


