About 50 Northville township voters turned out Monday night to see and hear the Republican slate of candidates running in next Monday's primary election

As most followers of township affairs know, the only competition on the ballot appears within the GOP ranks for the offices of supervisor and trustee. The session didn't advance beyond the stage of

at the annual meeting - which this year is scheduled two days before the April 1 election - on Saturday, March 30. The proposed increases - as reported in a page one Record story on December 6 - would boost the supervisor from \$4,000 to \$4,800, the clerk from \$3,200 to \$4,200 and the
