You are hereby commanded to collect from the several persons named in the Tax Roll hereunto annexed and herewith delivered to you, the several sums mentioned in the last column thereof opposite their respective names, and to retain in your hands the amount receivable by law into the Township Treasury for the following purposes, that is to say:

- Three hundred fifty  $\frac{\quad}{100}$  dollars for Township purposes;
- One hundred fifty  $\frac{\quad}{100}$  dollars for Highway purposes;
- Twenty-two  $\frac{36}{100}$  dollars for Excess of roll
- Four thousand one hundred sixteen  $\frac{63}{100}$  dollars for School purposes
- Eighteen +  $\frac{65}{100}$  dollars for District Highway purposes
- Ninety-six  $\frac{\quad}{100}$  dollars for Dog Tax purposes

and to account for and pay over to the County Treasurer:

- Nine hundred ten +  $\frac{75}{100}$  dollars for County purposes and
- Thirteen hundred forty-three +  $\frac{25}{100}$  dollars for State purposes, on or

before the first day of March next. And in case any person named in said Tax Roll shall neglect or refuse to pay his said tax, you are hereby authorized, <sup>and commanded</sup> to levy the same by distress and sale of the goods and chattels of such person, with the costs and charges of such distress and sale as provided by law; and for so doing this shall be your sufficient warrant.
